

Georgia WIC Formula Guide A Reference for WIC Approved Formulas



Revised February 2014 (See Highlighted Text)

Human Milk is considered to be the gold standard for infant feeding

Contract formulas not requiring medical documentation for infants (< 12 months old):

Approved Contract Milk Based Formula:

Gerber Good Start Gentle Gerber Graduates Gentle (age 9-11 months)

Approved Contract Lactose-Reduced Formula:

Gerber Good Start Soothe

Approved Contract Soy Based Formula:

Gerber Good Start Soy Gerber Graduates Soy (age 9-11 months)

Non-Contract formulas requiring medical documentation:

<u>Approved Non-Contract Rice-Added Formula:</u>

Enfamil A.R.

The following two conditions must exist prior to issuance of a Non-Contract Rice Added Formula:

- 1) Diagnosis of Gastroesophageal reflux disease (GERD)
 - **And** one of the following conditions:
- 2) Pneumonia, Tube feed, GERD Surgery (Fundoplication), Poor weight gain; Drop of at least one weight channel on growth chart. (Note: If weight is not provided, issuance will be based on weight obtained at WIC clinic.)
