# 2007 Georgia Data Summary: VIOLENT DEATH REPORTING SYSTEM



Types of violent death included: Suicide, homicide, unintentional firearm injury, legal intervention, and deaths of undetermined intent.

## **GEORGIA'S VIOLENT DEATH REPORTING, TYPE, AND LOCATION**

#### DESCRIPTION

- The Georgia Violent Death Reporting System (GVDRS) is part of the National Violent Death Reporting System (NVDRS)
- Funded by the Centers for Disease Control and Prevention, National Center for Injury Prevention and Control (CDC/NCIPC)
- Population-based system which is able to report on multi-victim incidents as well as on individual persons (victims and suspects)

### **MULTIPLE SOURCES OF DATA**

- Death certificates
- Medical examiner and/or coroner records
- Police records
- Supplemental homicide reports
- Crime laboratory records

#### **NVDRS GOALS**

- Inform decision makers about the magnitude, trends and characteristics of violent death
- Evaluate and continue to improve state-based violence prevention policies and programs




