

Governor's Public Safety Awards

We ask for your help identifying individuals who should be recognized for outstanding service to their community and profession. The criteria can be found at http://www.georgiagovernorspublicsafetyawards.org/selection-criteria/.

- Act of Heroism Award: The act of heroism must have occurred within the previous fiscal year July 1, 2022 June 30, 2023 to qualify.
 - Act of Heroism Award: When submitting a nomination for this award you need to ask yourself the question.... *Is this truly a heroic act or is it merely in the line of duty*?
- **Contribution to Profession Award:** Anyone nominated for this award should have a <u>minimum of 25</u> <u>years of service</u> and be someone who has made a <u>significant contribution to the betterment of their profession</u>.
- These categories are not intended to recognize employees for <u>merely "doing a good job"</u>, or responding to a call, but to <u>recognize employees who actually go beyond the ordinary to protect Georgia's citizens and property, or who contribute <u>significantly to the public safety profession.</u></u>
- When submitting a nomination via the website <u>a letter of support from the agency head, statewide association or</u>
 <u>statewide board should be uploaded with the supporting documents of the nomination</u>. If one cannot be provided, then the nomination cannot be accepted!

- 2. You will be prompted to *Create a New User* (enter your information as the nominator) and create a password.

- 4. Upload supporting documents related to the incident or contribution to profession, this must also include a letter of support from the agency head, statewide association or statewide Board-Click **Add Files**
- 5. Upload supporting documentation and Click Save





EMS Data Compliance and ePCR Vendor Compliance Policies (Released April 2023)



- OEMS-DM-2023-001 EMS Data Compliance and Reporting Policy
 - The intent of this policy is to specify the requirements for data compliance and reporting for all EMS Agencies currently licensed or seeking licensure by the Department. The new addition made to the policy is specified under sections 5.5-5.7. The policy will be in effect as of Monday, May 8, 2023.
- DEMS-VC-2023-001 EMS ePCR Vendor Compliance Policy
 - Or The intent of this policy is to specify the requirements, compatibility, and compliance of ePCR vendors for EMS responses from EMS Agencies in Georgia and the mandatory reporting requirements for NEMSIS v3.5 and all future NEMSIS versions. The policy will be in effect as of Monday, May 8, 2023.

GEMSIS Elite v3.5 Transition

- Hosted four webinars with EMS Agency Directors, Data Managers, Education Program Directors, and ePCR Vendors.
 - Webinar PowerPoint and Recordings posted on the GEMSIS page.
- Phase 1: Transition of GEMSIS Elite agencies to v3.5 (in process started July 2023) and testing of 3rd party ePCR software vendors (compliance testing).
 - Once the agency has determined your transition plan, contact Dipti Patel to discuss and determine a
 date and time.
- Phase 2: Transition of 3rd Party ePCR agencies (beginning August 2023)
 - ePCR vendors must be GA approved by no later than September 1st.
 - Once your ePCR vendor has been approved by Georgia, contact Dipti Patel to discuss and determine a
 date and time.
 - Georgia approved ePCR vendor status will be posted on the GEMSIS page.
 - Agencies with ImageTrend purchased system can begin transitioning when ready.
- All EMS agencies transitioned to v3.5 by November 1st!
- Don't wait until the last minute to complete your transition.

What does this mean for EMS Agencies?

- NEMSIS v3.5 Validation Rules
 - Total of 293 Validation Rules
 - 97 rules from v3.4 converted to v3.5
 - 14 new rules created to include v3.5 changed elements and values
 - 182 current rules updated to include v3.5 changed elements and values
- Agencies using GEMSIS Elite Directly: All current and NEW (optional and required) v3.5
 data elements have been added to the State v3.5 EMS ePCR form and Print Report that
 are available in the NEMSIS data dictionary.
 - State v3.5 EMS ePCR Form and Print Report are available under each agency but made Inactive. Contact Dipti Patel for instructions or any questions.
 - EMS Agencies will be responsible to add all the new optional and required fields on your custom ePCR form and print report (if applicable).
- **Agencies using 3rd Party Vendor System**: v3.5 Schematron File, Validation Rules and Facilities List published on the GA NEMSIS page.

Additional Fields Added to EMS Form

- Also added additional data elements to current and v3.5 ePCR form and Print Report.
 - Stoke Scale Severity Score (itVitals.096)
 - Patient Identification Number (MRN #) and Patient Identification Number (Armband #)
 - External Report ID, Number Type (eOutcome.03)
 - External Report ID/Number (eOutcome.04)
 - Another Provider on scene (non-EMS) (supplemental question)
 - Telehealth/Nurse Navigator, etc. programs
 - Alternative Disposition Offer and Result (et3Disposition.01)

Expectations of EMS Agencies

- Review the new two data policies published by OEMST and confirm your EMS agency is compliant with these two policies (available on DPH EMS Website).
- EMS Agencies are responsible for educating their medics on the updated ePCR documentation including data element and value changes, new validation rules, current documentation issues, etc.)
- EMS Agencies are **responsible** to complete all the transition preparation steps as soon as possible.
- Use the recommended checklists and other transition materials created to assist with transition (available on the GEMSIS page).
- Communicate with OEMST and ePCR vendor about your agency's transition plan, questions or any other changes.





- Students will now complete a "Student Minimum Competency (SMC)
- More of a portfolio and follows a progression of learning
- EMR/EMT psychomotor exams will end January 1, 2024

Georgia EMR/EMT Transition

June 2023 – Release EMR/EMT Student Minimum Competency (SMC)/Portfolio

This will include the required lab skills and Clinical/Field skills

January 2024 – All EMR/EMT courses approved after this date will use the SMC and **NOT** a psychomotor exam

July to January we will host Mandatory Training on the SMC rollout in each region

• 4 hour session

Mandatory Training

All **Program Directors and Course Coordinators** will be required to complete the Student Minimum Competency (SMC) update course

Highly encouraged for ALL instructors

Course will be offered for all regions, multiple times from July – January
