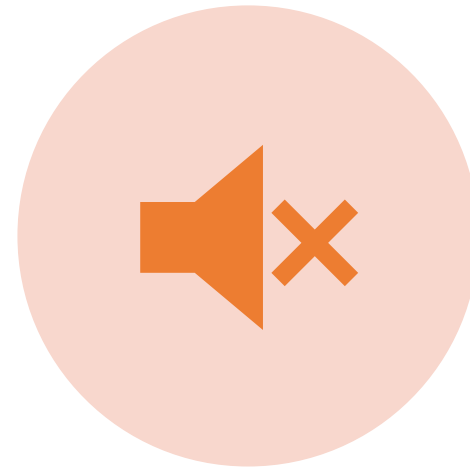

LMS Public Portal:

- If a user needs to update their email address in LMS in order to login, they will now have to request the change via email.
 - User will need to email us at dph-phemsinfo@dph.ga.gov with the email change request.

Welcome to the Georgia EMS License Management System!

The Georgia EMS system uses the e-Licensing Portal for all:

- EMS students (course enrollment)
- Individual medics (initial license application or license renewal)
- Hospitals seeking designation as a:
 - Trauma Center
 - Emergency Cardiac Care Center
 - Stroke Center
- EMS agencies (initial license application, license renewal, updates to personnel roster)

The Georgia Office of EMS and Trauma uses the email address in your account as the primary source of communication. Please ensure that your contact information is kept current.

Active Account User

If you are a currently licensed EMS healthcare practitioner in Georgia, login to your existing License Management System account. Please do **NOT** create a new account. Duplicate accounts will be deleted. If you forgot your user name or password, please select the "Forgot" feature by the login fields below.

GEMSIS Elite v3.5 Transition

- Currently transitioning EMS Agencies using **GEMSIS Elite system directly** and agencies using **ImageTrend purchased systems**.
 - You will need to contact Dipti Patel with a date and time to complete your transition.
 - **The transition will not occur until someone from your agency notifies Dipti Patel.**
- EMS Agencies currently using a **3rd party ePCR software system**, will need to be in touch with your ePCR vendor to find out their status for the GA v3.5 transition.
 - Expecting all ePCR vendors to complete the GA compliance testing by no later than **September 1st**.
 - **Georgia EMS Agencies will not be able to submit v3.5 data until your ePCR vendor has completed the compliance testing.**
 - GA compliance testing is separate from the NEMSIS compliance testing that each vendor will have to complete.
 - Agencies will be notified by Dipti Patel once an ePCR vendor successfully completes the GA compliance testing.
 - **All EMS agencies must be transitioned to v3.5 by November 1st!**



Expectations of EMS Agencies

- EMS Agencies are **responsible** for educating their medics on the updated ePCR data elements and value changes, new validation rules, current documentation issues, etc.
- EMS Agencies are **responsible** to complete all the transition preparation steps as soon as possible.
- Use the recommended checklists and other transition materials created to assist with transition (available on the GEMSIS page).
- Communicate with OEMST and ePCR vendor about your agency's transition plan, questions or any other changes.

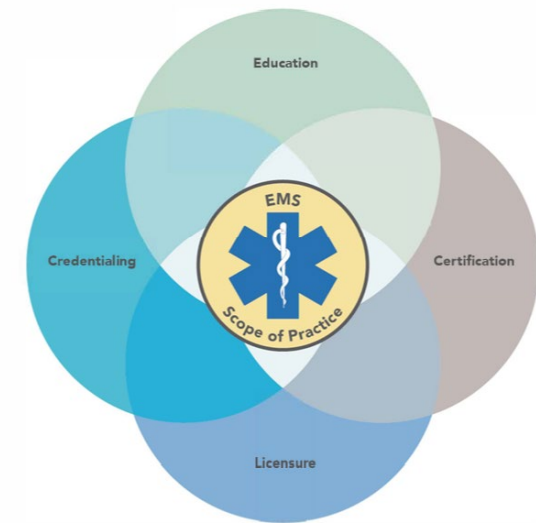

Pass Rate Aggregation

The reported data will be aggregated for a 3-year period and will be updated every 6 months (January and July) on a rolling schedule.

The report will be based on a Georgia peer-to-peer benchmark in which the 3rd cumulative attempt average will be the midpoint.

Publication will begin on January 1, 2024 to the OEMST website

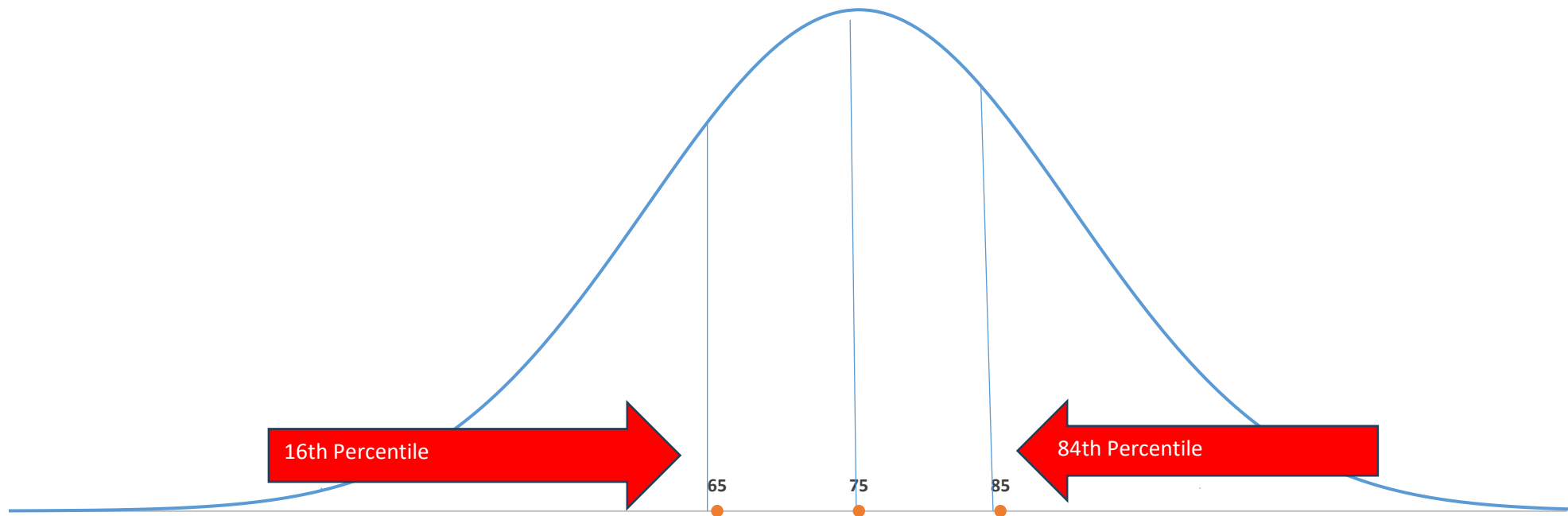
Example

The 202X 3rd cumulative EMT pass rate is 75%. Using the bell curve, 1 standard deviation to the right would represent 10 percentage points, or an 85% pass rate.

- 85% or higher pass rate will be a “High Performer”
- 75-84% will be an “Above Average Performer”
- 65-74% will be a “Below Average Performer”
- <65% will be a “Poor Performer”

Student Minimum Competency (SMC/Portfolio)

Georgia EMR/EMT Transition

June 2023 – Release EMR/EMT Student Minimum Competency (SMC)/Portfolio

- This will include the required lab skills and Clinical/Field skills

January 2024 – All EMR/EMT courses approved after this date will use the SMC and **NOT** a psychomotor exam

Mandatory Training

All **Program Directors, Program Admins, Course Coordinators, Clinical Coordinators**, and any **faculty** involved in the completion of End of Course paperwork will be required to complete the Student Minimum Competency (SMC) update course

- Highly encouraged for ALL instructors

Course will be offered for all regions, multiple times from July – January
