This memorandum provides guidance on how to implement the 2018 National WIC Association (NWA) wall and pocket calendars within Georgia's Special Supplemental Nutrition Program for Women, Infants, and Children (WIC). NWA will begin shipping the 2018 calendars to local agencies the week of November 13, 2017. The attached shipping summary outlines the number of calendars by type, as well as, the designated shipping address. The Approved Education Materials List was revised to include the 2018 NWA calendars and posted to the district resources web page on October 16, 2017.

This year's NWA calendar is titled "12 Steps to a Healthier Lifestyle". Each month features a lifestyle goal, like getting enough sleep, exercising more, managing food portion sizes, eating more fruits and vegetables, and choosing healthier beverages and snacks. Web resources are also provided to help families practice these healthy habits.

The 2018 NWA calendar can be used as a nutrition education reinforcement material during counseling and nutrition education classes, as appropriate. The calendar can also be used to provide program outreach or to document upcoming WIC appointments. Districts are encouraged to establish a distribution plan for the 2018 calendars, advise staff on distribution procedures, and begin distributing immediately, upon receipt.

Action Steps:

- Confirm receipt of, and verify the quantities received for the 2018 NWA wall and pocket calendars to Angela Bradford, via email at <u>angela.bradford@dph.ga.gov</u> by November 30, 2017.
- 2. Establish a local agency distribution plan and train staff on how to provide the 2018 NWA wall and pocket calendars to all WIC families, over the next several months.
