## **Policy**

Local Agency Staff, excluding Breastfeeding Peer Counselors, must attempt to recover and track multi-user breast pumps no longer being used, or without successful monthly follow-up contact with the participant.

## **Purpose**

To minimize costs associated with replacing unreturned pumps.

#### **Procedures**

Local agency staff must:

- I. Complete all issuance follow up steps as detailed within <a href="Policy 1260.06 Pump">Policy 1260.06 Pump</a> Issuance.
- II. Mail the <u>Final Request for Return of Medela Symphony® Breast Pump letter</u> to the participant and the alternate contact five to ten calendar days after the deadline outlined in the <u>Multi-User Breast Pump Follow Up letter.</u>
- III. Complete the following steps to report retrieval efforts after mailing the <u>Final</u>
  Request for Return of Medela Symphony Breast Pump letter:
  - A. Update WIC Breast Pump Inventory Tracking System as "Lost."
  - B. Complete the Lost or Stolen Multi-User Electric Breast Pump Report.
  - C. Submit copies of the following to the State WIC Office Breastfeeding Unit at <a href="mailto:Gawic.breastfeeding@dph.ga.gov">Gawic.breastfeeding@dph.ga.gov</a>:
    - 1. Lost or Stolen Multi-User Electric Breast Pump Report
    - 2. <u>Multi-User Electric Breast Pump Loan Agreement</u>
    - 3. <u>Multi-User Breast Pump Follow Up letters</u> to both the participant and alternate
    - 4. <u>Final Request for Return of Medela Symphony® Breast Pump</u> letters to both the participant and alternate
    - 5. Most recently signed copy of the participant's Rights and Responsibilities
    - 6. Pertinent medical record information that supports local recovery efforts
