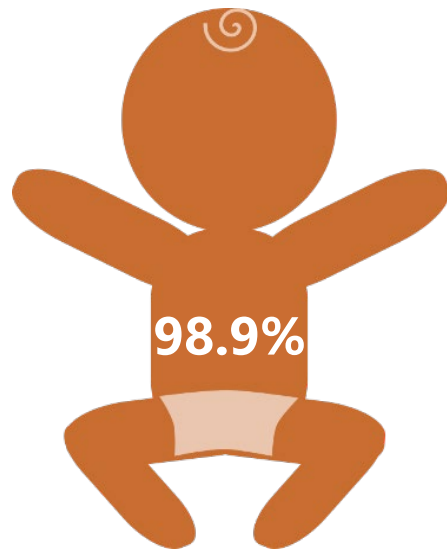

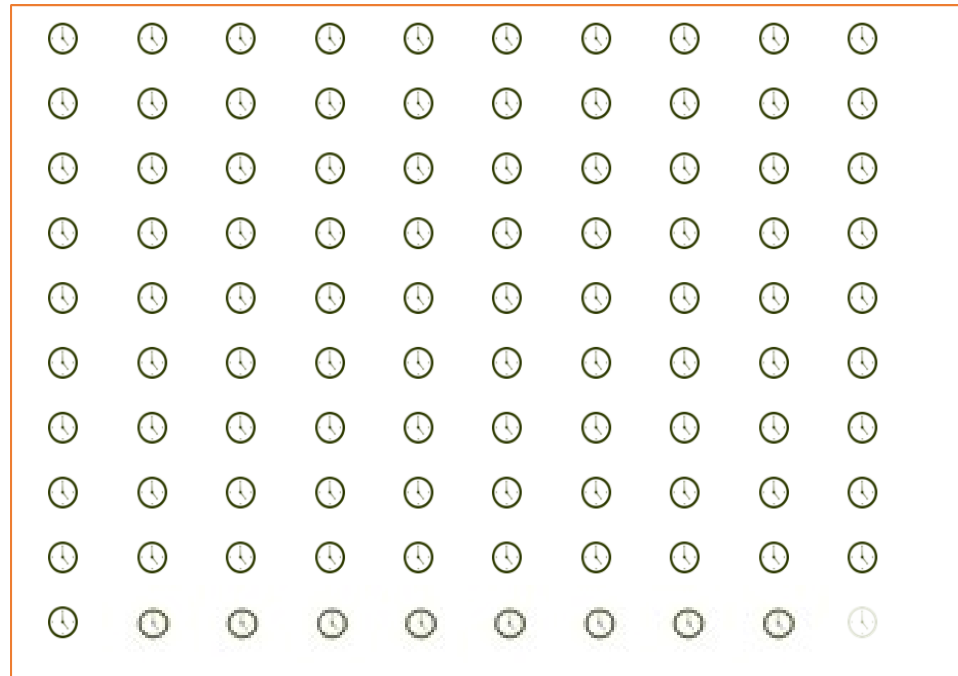

Percent of infants and toddlers with Individualized Family Service Plans (IFSP) who receive early intervention services on their IFSPs in a timely manner.



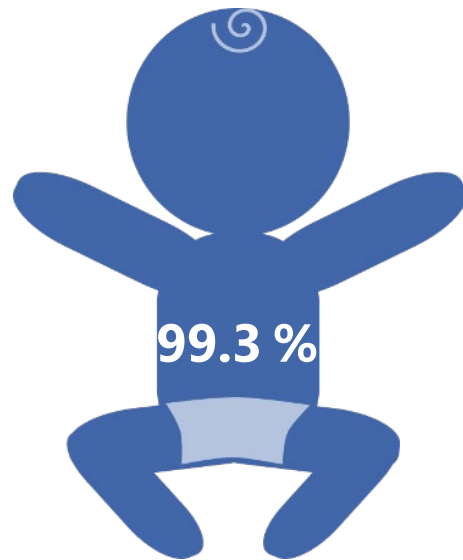

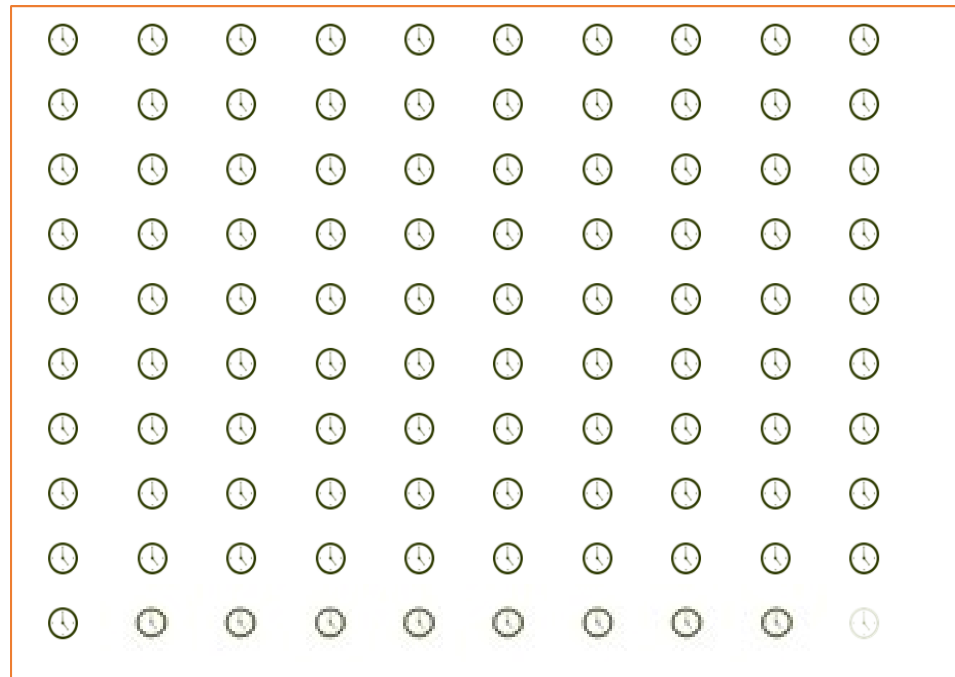
In FFY 2021, **98.9%** of infants and toddlers received timely services.

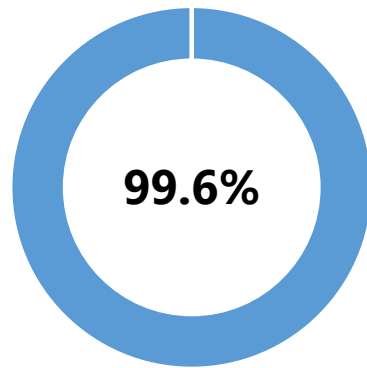

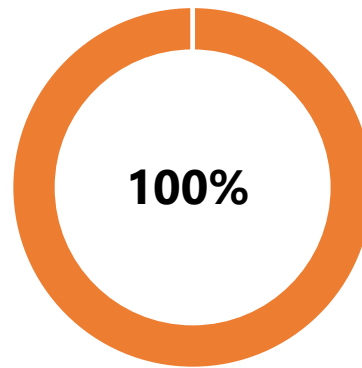
Indicator 8: Early Childhood Transition

Services Within Timeline



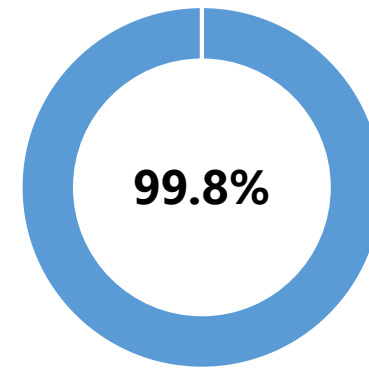
8A: Transition Steps & Services

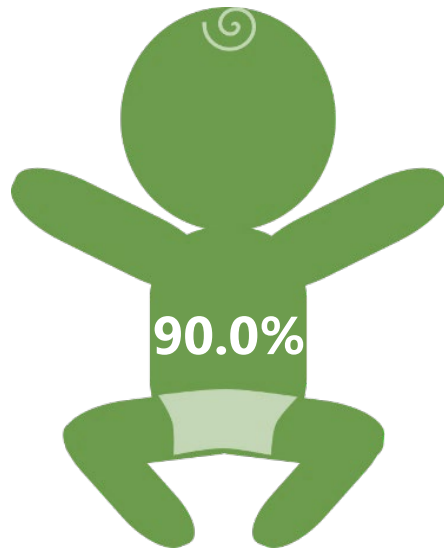
***8A Timely:** Developed an IFSP with transition steps and services at least 90 days and not more than 9 months prior to the 3rd birthday.

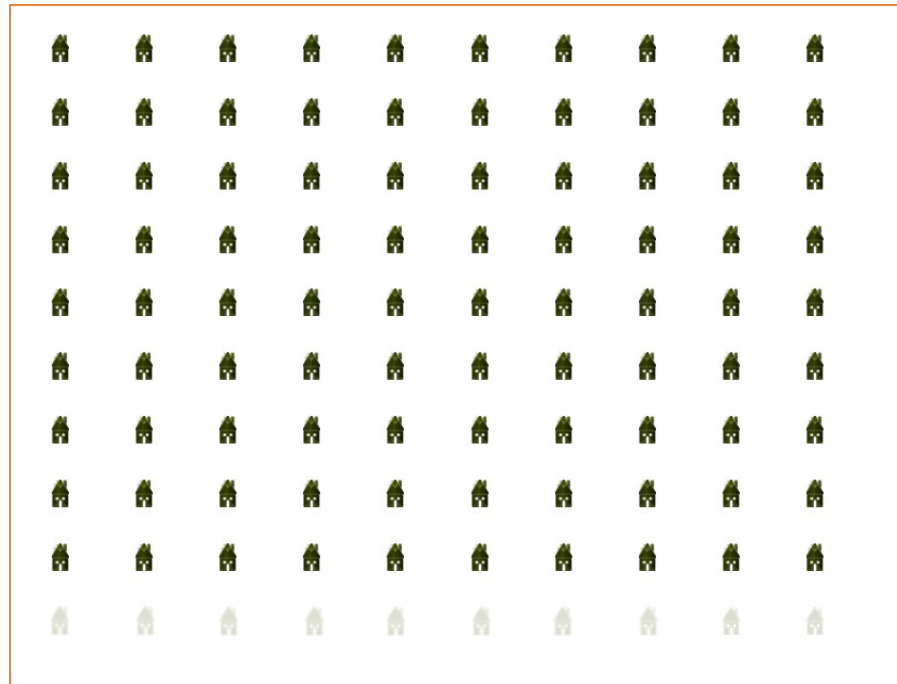
***8C Timely:** Conducted the transition conference at least 90 days and not more than 9 months prior to the 3rd birthday for children potentially eligible for Part B preschool services.

Indicator 3A: Positive Social-Emotional Skills

Indicator 3A: Positive social-emotional skills

This indicator measures infants and toddlers' positive social-emotional skills (including social relationships). It is calculated as two summary statements that examine the percentage of infants and toddlers who increase their rate of growth in positive social-emotional functioning (Summary Statement 1) and the percentage of infants and toddlers who function at a level comparable to their same-aged peers (Summary Statement 2).

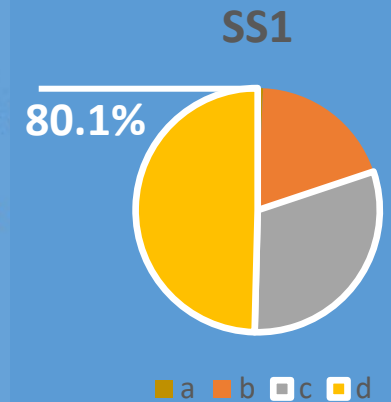

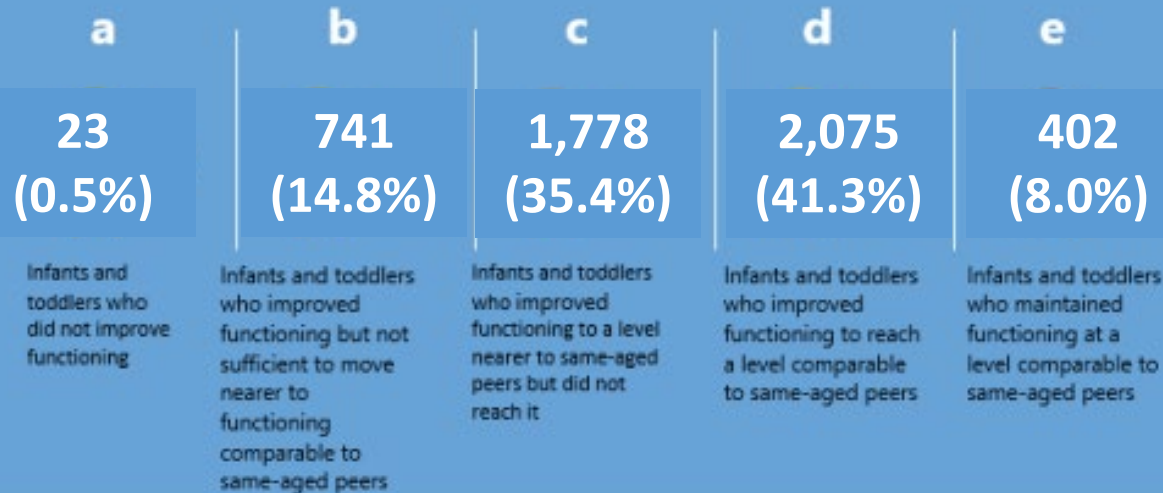

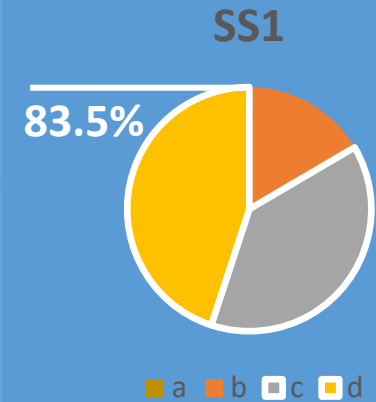
Indicator 3B: Acquisition & Use of Knowledge & Skills

Indicator 3B: Acquisition and use of knowledge & skills

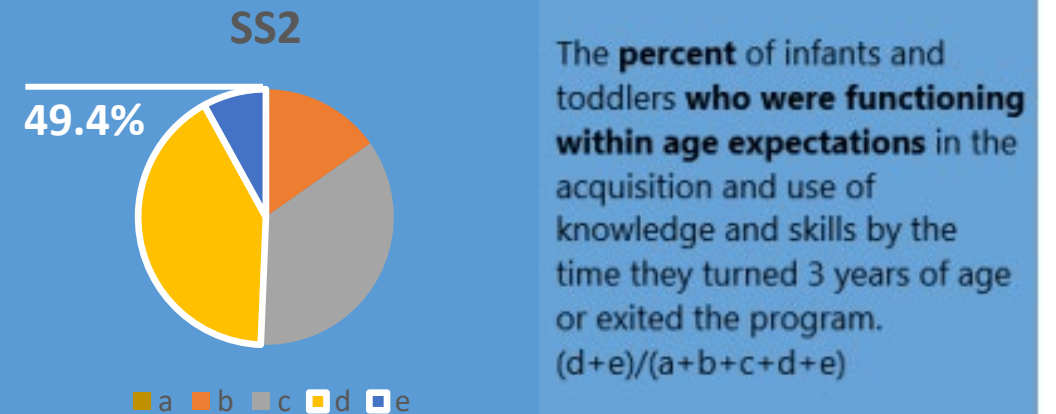

It is calculated as two summary statements that examine the percentage of infants and toddlers who increase their rate of growth in the acquisition and use of knowledge and skills (Summary Statement 1) and the percentage of infants and toddlers who function at a level comparable to their same-aged peers (Summary Statement 2).



Of those infants and toddlers who entered early intervention below age expectations in acquisition and use of knowledge and skills, the **percent who substantially increased their rate of growth** by the time they turned 3 years of age or exited the program. $(c+d)/(a+b+c+d)$

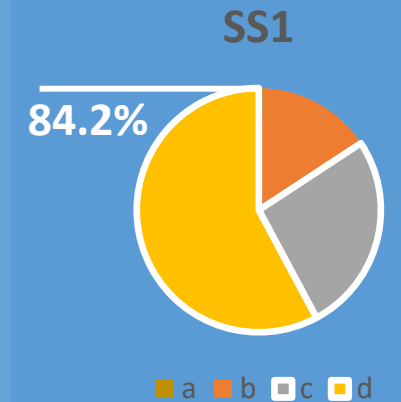

Indicator 3C: Use of appropriate behaviors to meet their needs

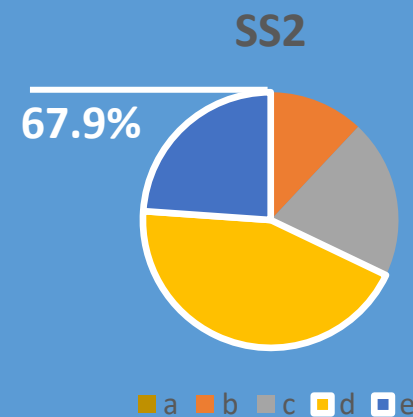

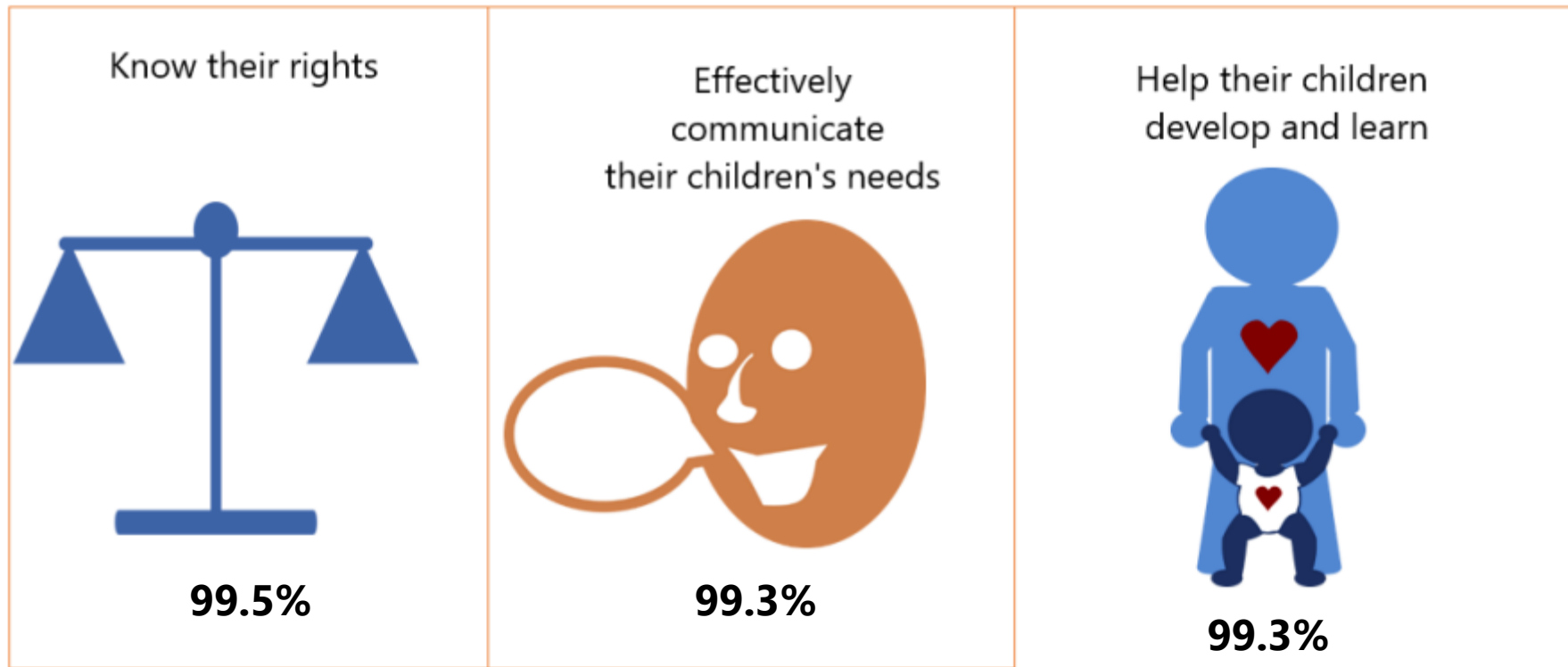

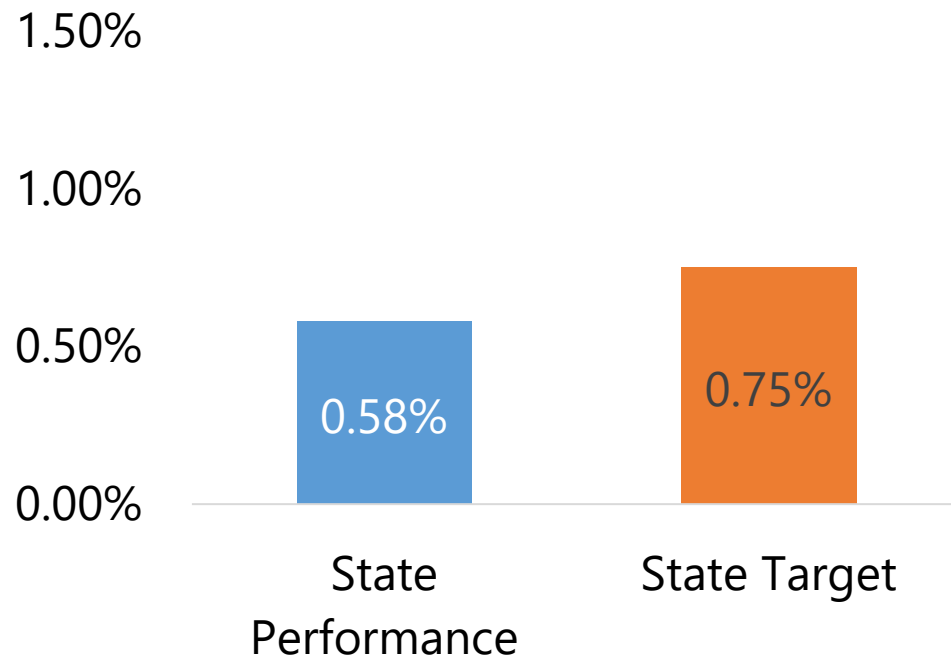

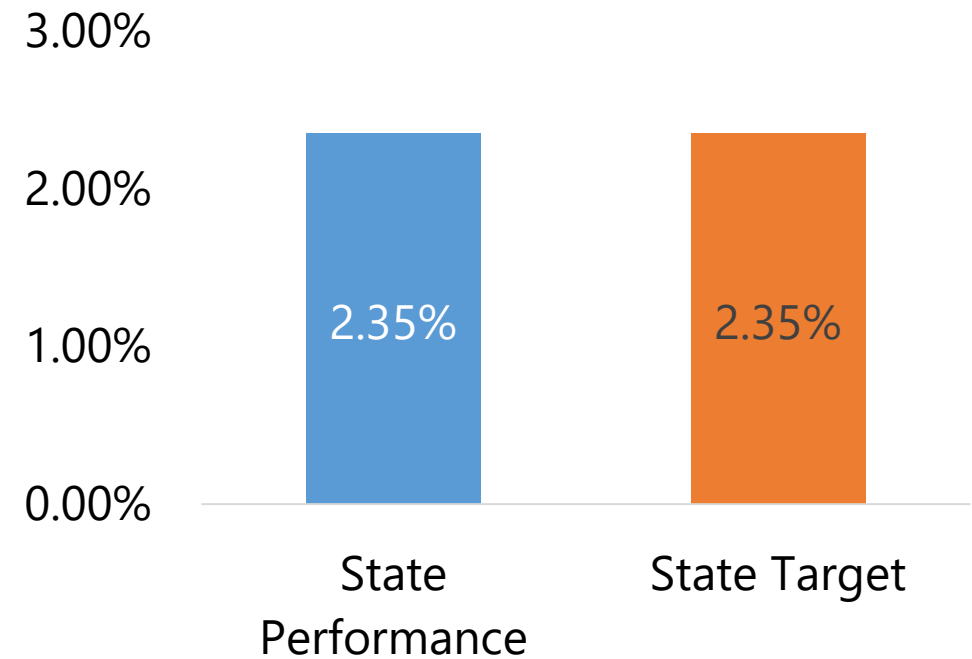
Indicator 5: Child Find, Ages Birth to 1

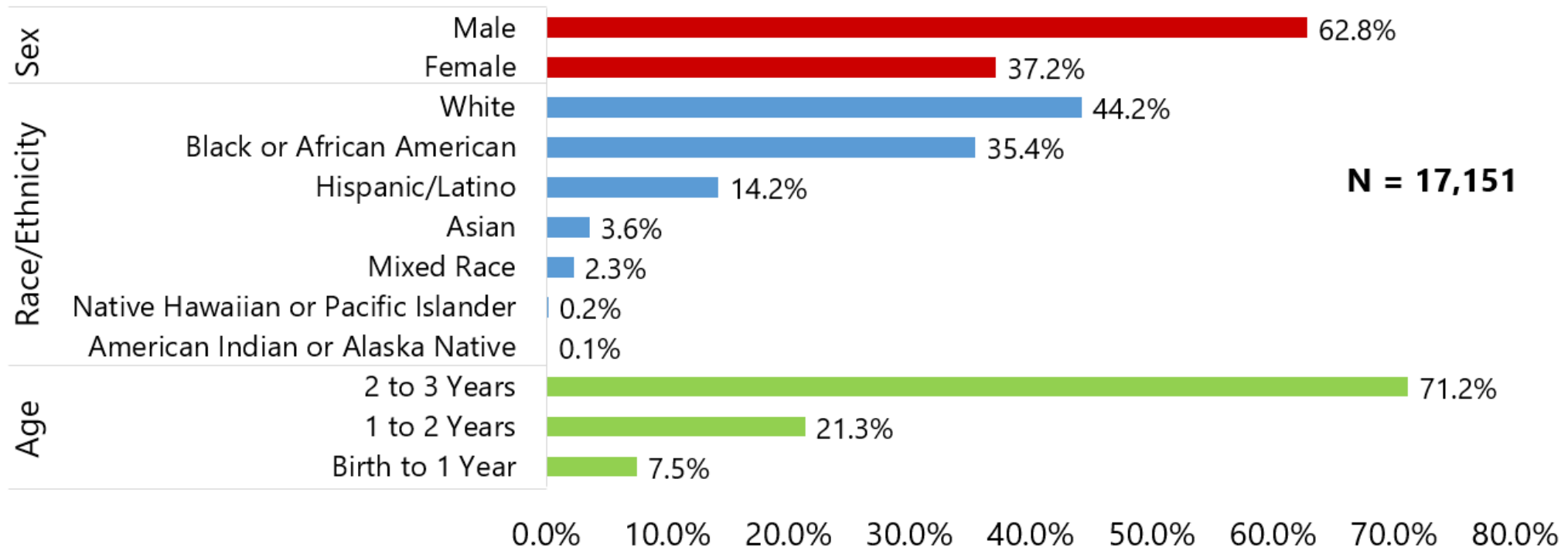
Percent of infants and toddlers ages birth to three with IFSPs*
