

Updated Guidance (as of 2/14/2020) for Public Safety Personnel Responding to patients with fever and respiratory symptoms and those with a positive travel history

Please note that this guidance replaces the previous Georgia Office of EMS and Trauma guidance that was released on 1/30/2020.

The Georgia Department of Public Health (DPH) and the CDC are closely monitoring the outbreak of respiratory illness caused by COVID-19 (the official name for the disease that is causing the 2019 novel coronavirus outbreak) that was first detected in Wuhan City, Hubei Province, China and which continues to expand. DPH is working with all of our federal, state and local partners in preparation for and response to this emerging public health threat. As part of that response, DPH is recommending that EMS agencies and 911 Public Safety Answering Points (PSAPs) follow the current guidance from the CDC. 911 centers may also choose to use the latest Emerging Infectious Disease Surveillance Tool (Coronavirus/SRI/MERS/Ebola) published by the International Academies of Emergency Dispatch.

In addition to the guidance from the CDC, public safety agencies are encouraged to notify the Georgia Department of Public Health Medical Epidemiologist on call at 1-866-PUB-HLTH (1-866-782-4584) to report a patient with a positive travel history, fever and signs/symptoms of a lower respiratory illness (e.g., cough or shortness of breath).

Electronic Patient Care Report (ePCR) Documentation

- Recent Travel/Travel Locations
 - As a reminder, all EMS personnel are *required* to document the recent travel question (itExam.070 – "*Has the patient traveled outside their community within the last 30 days*?") on ALL patient contacts in their ePCR.
 - "Community" is defined by the medical director and need not be limited to just travel outside of the United States.
 - Choices for the travel question include: "No," "Yes," "Unknown," "Unresponsive," "Refused."
 - If the answer to the travel question is "Yes," then the medic is required to answer the following additional questions:
 - o itExam.072 Beginning Travel Date
 - o itExam.071 Ending Travel Date
 - itExam.074 Travel Locations (Document all places and locations the patient has traveled in the last 30 days)
- Narrative
 - Include the term "COVID-19" in the narrative (eNarrative.01) for any patient that has a positive travel history (as defined by the CDC for COVID-19).
