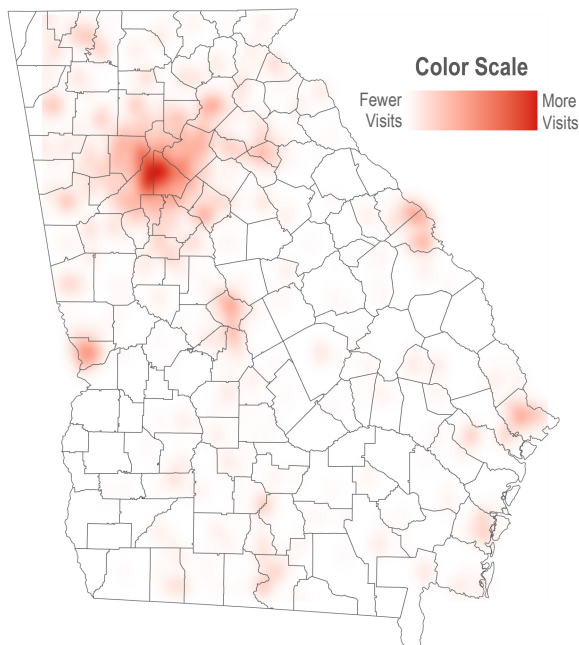


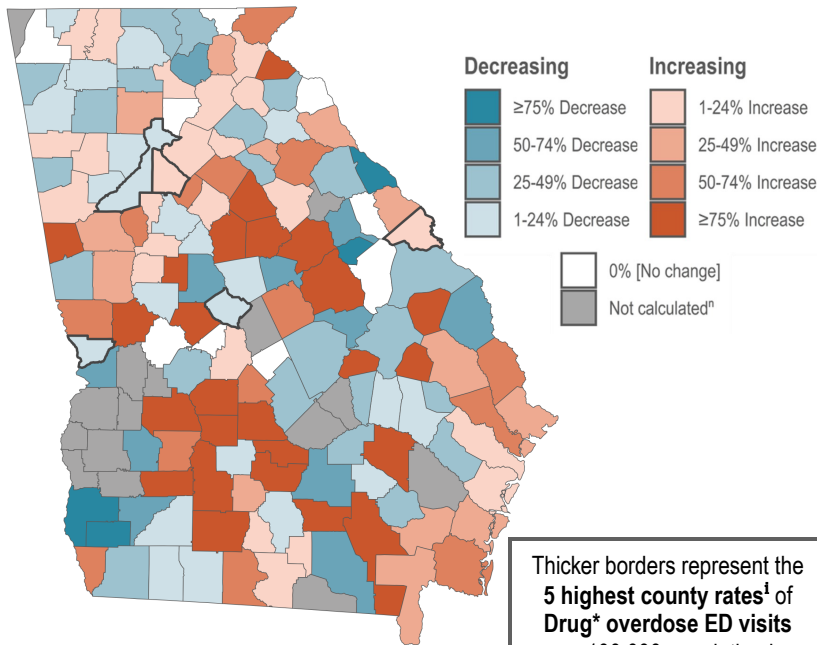
# Syndromic Surveillance Drug Overdose Emergency Department Visits: Georgia, October 2025

**What is Syndromic Surveillance (SyS)?** SyS is used as an early detection method for potential clusters or outbreaks, by tracking suspected drug overdose-involved emergency department (ED) visits based on the patient's chief complaint upon admission and/or discharge diagnosis. Participating Georgia hospitals and urgent care facilities share these SyS data within the State Electronic Notifiable Disease Surveillance System (SendSS).

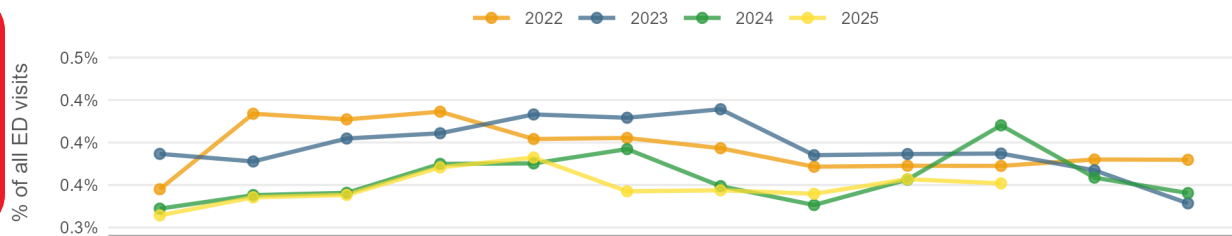

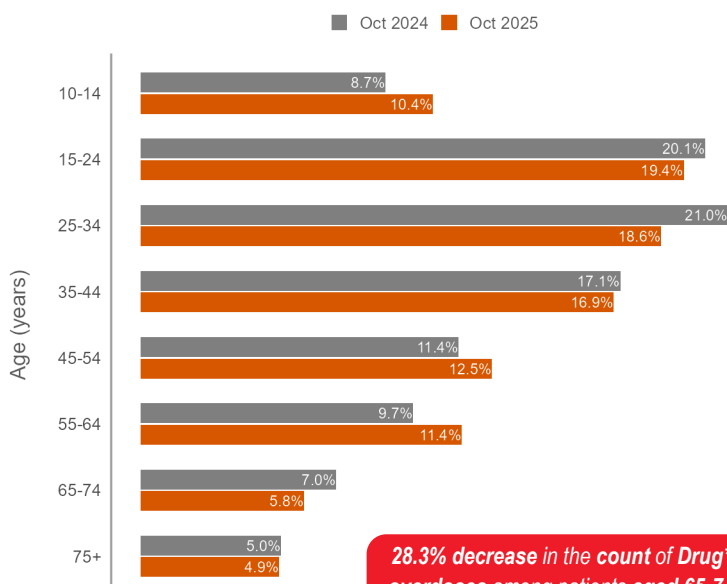

### Percent of All Drug\* Overdose ED Visits by Age Group

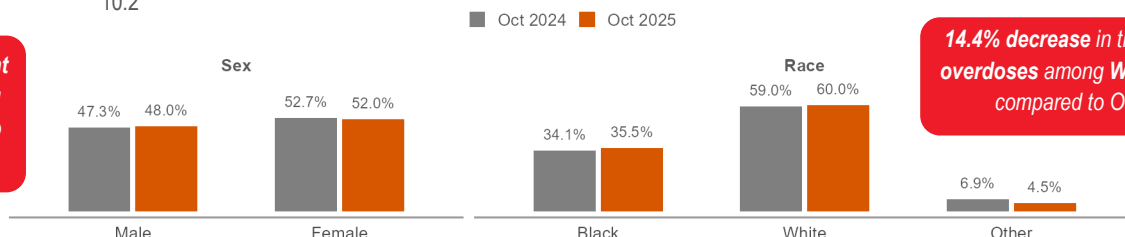


Drug\* overdose ED visits in October 2025 were predominantly: Female (52.0%), White (55.2%), and between 15-24 years of age (19.4%).

28.3% decrease in the count of Drug\* overdoses among patients aged 65-74 when compared to October 2024.

15.2% decrease in the count of Drug\* overdoses among Females when compared to October 2024.



14.4% decrease in the count of Drug\* overdoses among White patients when compared to October 2024.

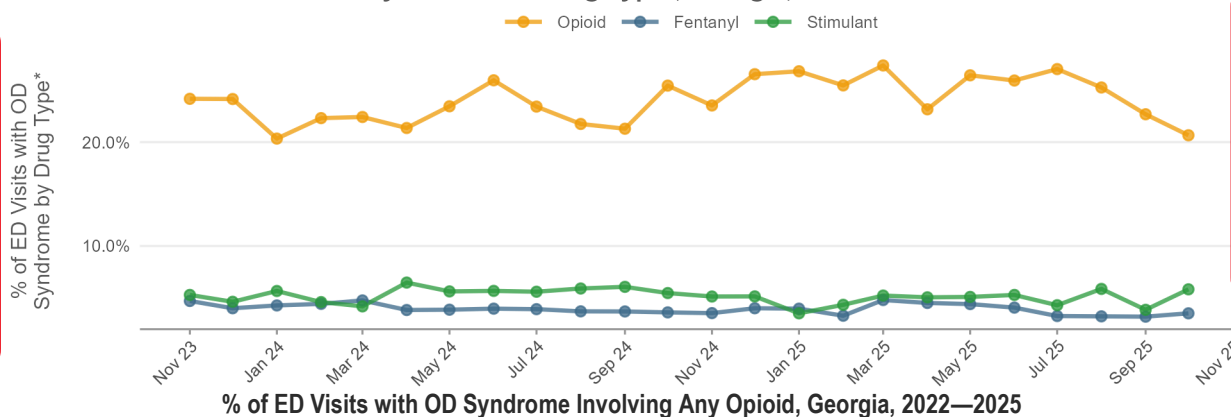
