NOTICE OF PROPOSED RULEMAKING
Repeal of Public Health Regulation
Chapter 290-5-30 “Emergency Medical Services”


Please take note that the Department of Public Health proposes to repeal Chapter 290-5-30 “Emergency Medical Services” pursuant to its authority under O.C.G.A. § 31-2A-6.

Chapter 290-5-30 was originally promulgated several decades ago, when Public Health was a division of the Department of Human Resources. After Public Health was transferred to the Department of Community Health in 2009, the regulations governing emergency medical services were renumbered and promulgated as Chapter 111-9-2. However, the previous Chapter 290-5-30 was not repealed at that time. After Public Health became a separate Department in 2011, the regulations governing emergency medical services were renumbered again and promulgated as Chapter 511-9-2, which are in effect today. The purpose of this proposed rulemaking is solely to repeal Chapter 290-5-30, which is obsolete and redundant, and is not intended to have any effect on the regulations currently published as Chapter 511-9-2.
