1.0 PURPOSE

The intent of this policy is to specify recognized instructional techniques and instructional preparation curriculum courses for EMS Instructor and EMS Instructor/Coordinator licensure applicants, respectively.

2.0 AUTHORITY

The Georgia Department of Public Health, Office of EMS and Trauma, OEMS-INS-2021-002, Recognized EMS Instructor Courses Policy is published under the authority of the Department and in compliance with the following:

- 3.2 "Department" means the Georgia Department of Public Health, Office of EMS and Trauma.
- 3.3 "EMS Rules" means the Department's Rules and Regulations, Chapter 511-9-2.
- 3.4 "EMS Instructor Courses" means the list of Department Recognized Instructional

3.5 "Recognized" means acceptable to the Department based on its determination as to conformance with current national standards.
