




PCR Cases Over Time (By date of report)



Confirmed Deaths by Date of Report




Confirmed Deaths by Date of **Death**





Vaccination Rates (as of 5/11/2022) At least 1 dose = 64%; Fully Vaccinated = 56%





WHEREAS:	It is proper and timely to bring recognition to the value and accomplishments of Emergency Medical Services for Children and the dedicated men and women who work tirelessly to improve the quality of pediatric medical care; now

Current Emergency Rule

Emergency Rule 511-9-2-0.5 containing Rule 511-9-2-0.5-.12 entitled "Temporary Licenses and License Reinstatements for Emergency Medical Services Personnel for COVID-19 Response"

Rule became effective on 1/28/2022 for 120 days Rule is effective till <u>5/27/2022</u> (14 more days)

- Temporary Compact License: a person who holds a current EMS license in good standing, including remote state privilege to practice, in another member state of the Interstate Commission for EMS Personnel Practice ("Compact"). License is good for 120 days
- License Reinstatements: License was in good standing when the license lapsed for failure to renew between March 31, 2019 and March 31, 2021 (2019, 2020, 2021).

Reinstatements

Requirements:

- Previous Georgia non-provisional and non-temporary medic license
- License was in good standing when the license lapsed for failure to renew between March 31, 2019 and March 31, 2021 (2019, 2020, 2021).
- Medics that expired March 31, 2022 are not eligible for the Reinstatement application. They must complete a Late Medic Renewal application.

Temporary Compact License

A license at the EMT, AEMT, or Paramedic level that is issued by the Department to a person who holds a current EMS license in good standing, including remote state privilege to practice, in another member state of the Interstate Commission for EMS Personnel Practice ("Compact").

License is good for 120 days (one-time at the respective application level)

Allows those medics to quickly begin working in Georgia while allowing them time (120 days) to gain full licensure.

1.0 PURPOSE

The intent of this policy is to establish guidelines for Congenital Adrenal Hyperplasia training for EMS personnel. This education is mandatory pursuant to O.C.G.A. § 31-11-5.2

2.0 AUTHORITY

The Georgia Department of Public Health, Office of <u>EMS</u> and Trauma (Department), Congenital Adrenal Hyperplasia Training Policy is published under the authority of the Department and in compliance with the following:

2.1 Official Code of Georgia Annotated (O.C.G.A.) § 31-11-1 et seq.

- 5.1 EMS Personnel.
 - 5.1.1 EMS Personnel whose license expires in the year 2023, who did not complete the Georgia OEMST Congenital Adrenal Hyperplasia course on TRAIN Georgia as part of their initial EMS education, must complete this training on or before March 31, 2023 (EMT, AEMT, Paramedic) or before September 30, 2023, for EMT-R as part of their continuing education requirement.
 - **5.1.2** EMS Personnel whose license expires in the year 2024, who did not complete the Georgia OEMST Congenital Adrenal Hyperplasia course on TRAIN Georgia as part of their initial EMS education, must complete this training on or before March 31, 2024 (EMT, AEMT, Paramedic) or before September 30, 2024, for EMT-R as part of their continuing education

requirement.

- **5.1.3** EMS Personnel who receive an initial EMS license after March 31, 2022, will be required to complete the Georgia OEMST Congenital Adrenal Hyperplasia course on TRAIN Georgia.
- **5.1.4** Once completed, the training does not need to be completed for any future license renewal cycles.

- 5.2 Initial EMS Education.
 - 5.2.1 All initial EMS education courses beginning on or after June 1, 2022, will be required to include the Georgia OEMST Congenital Adrenal Hyperplasia course on TRAIN Georgia as part of the initial EMS education curriculum.
 - **5.2.2** A student only needs to complete this training once during their initial EMS education.

Gov. Kemp Awards \$13M in Settlement Funds to Help Fight Opioid Crisis

FEBRUARY 17, 2022

Atlanta, GA – Governor Brian P. Kemp today announced the award of \$13,081,929 in funds from the State of Georgia's <u>settlement with McKinsey & Company</u> to be used to address the negative effects of opioid misuse and to invest in opioid abatement strategies. The funds will be utilized to expand Medication Assisted Treatment (MAT) availability, increase detoxification service capacity, promote stigma reduction, increase access to naloxone for emergency service providers, and expand training on naloxone to community providers.

"The opioid crisis has affected - either directly or indirectly - almost every Georgia family," **said Governor Brian P. Kemp.** "We appreciate the Office of the Attorney General for working to represent the interests of Georgians throughout this litigation, and we look forward to ensuring these funds are leveraged to help us combat the scourge of opioid misuse in our state."

Funds will be distributed through Memorandums of Understanding between the Department of Law, the Department of Behavioral Health and Developmental Disabilities (DBHDD), and the Department of Public Health (DPH). Provide naloxone kits to Emergency Medical Service providers

Emergency Medical Service providers (EMS) personnel indicated to DPH the ongoing need for naloxone kits. \$2,017,929 will provide for DPH to distribute approximately 326,000 naloxone kits to EMS providers.
