Georgia Prescription Drug Monitoring Program (PDMP) Monthly Report—March 2023


What is the PDMP? The PDMP is an electronic database used to collect, monitor, and analyze prescribing and dispensing data about controlled substances (such as opioids, benzodiazepines and stimulants) in Georgia. The PDMP collects details of every Schedule II – V prescription drug order dispensed in Georgia. The purpose of this report is to describe opioid prescribing patterns in Georgia on a monthly basis. Disclaimer: The data in this report increased when compared to the previous reports due to changes in the reporting process. PDMP surveillance reports prior to January 2022 should not be compared with reports after January 2022.

From 2021 to 2022, the number of opioid prescriptions decreased by 3%, benzodiazepine prescriptions by 3%, and stimulant prescriptions increased by 1%.

Prescriptions by Drug Type & Month, Georgia, 2022-2023






