

Georgia Prescription Drug Monitoring Program (PDMP) Monthly Report—August 2020

<u>What is the PDMP?</u> The PDMP is an electronic database used to collect, monitor, and analyze prescribing and dispensing data about controlled substances (such as opioids, benzodiazepines and stimulants) in Georgia. The PDMP collects details of every Schedule II – V prescription drug order dispensed in Georgia. The purpose of this report is to describe opioid prescribing patterns in Georgia on a monthly basis. From 2018 to 2019, the number of opioid prescriptions decreased by 8% and benzodiazepine prescriptions also decreased by 14%. Stimulant prescriptions decreased by 14%.

Prescriptions by Drug Type & Month, Georgia, 2019-2020


