
Georgia Prescription Drug Monitoring Program (PDMP) Quarterly Report—2024 Q1

<u>What is the PDMP?</u> The PDMP is an electronic database used to collect, monitor, and analyze prescribing and dispensing data about controlled substances (such as opioids, benzodiazepines and stimulants) in Georgia. The PDMP collects details of every Schedule II – V prescription drug order dispensed in Georgia. The purpose of this report is to describe opioid prescribing patterns in Georgia on a monthly basis. 
Q1: January-March, Q2: April-June, Q3: July-September, Q4: October-December

From 2022 to 2023, the number of opioid prescriptions decreased by 2%, benzodiazepine prescriptions by 2%, and stimulant prescriptions by 1%.

Prescriptions by Drug Type & Month, Georgia, 2021 Q1-2024 Q1






