**The New Year Welcomes GRITS 2.0!** The Georgia Department of Public Health (DPH) announced that the Georgia Immunization Registry (GRITS) will be transitioned to a new platform. The GRITS 2.0 project is underway and with the New Year comes more frequent updates regarding this project to ensure that you and your systems are ready for Georgia's new immunization information system to go live in Quarter 2 of 2024. This email update will be one of the ways we ensure our stakeholders are informed of important information and activities.

DPH is working hard to ensure the new platform will provide healthcare providers, schools, pharmacies, state agencies and other immunization partners a user-centric experience that provides the vaccine intelligence needed to "monitor, manage, and mobilize data for a healthier future." Our goal is to deliver you the technology to establish real-time data exchange, manage your vaccine-related supplies, and have up to date clinical decision-making support.

#### DATA EXCHANGE READINESS

Providers who currently report to GRITS through their EHR/EMR using HL7 or via Flat File must transition their connections **BEFORE GRITS 2.0 is LIVE** 

Here are a few items to note as we work through the transition to GRITS 2.0.

- Per O.C.G.A § 31-12-3.1 and House Bill 1526, reporting to GRITS by "any person who administers a vaccine or vaccines licensed for use by the United States Food and Drug Administration to a person" remains continuously in effect regardless of this transition.
- All EMR/EHRs sending data electronically must be at least 2014 ONC Certified.
- GRITS 2.0 supports HL7 Version 2.5.1 as recommended by the Centers for Disease Control and Prevention (CDC). Additional information will be provided to providers reporting alternate versions of HL7.

If your EMR/EHR is unable to meet the requirements for electronic data exchange, reporting via Flat File will be available.

Providers and EMR/EHR vendors are HIGHLY encouraged to begin reviewing the **IIS Health Level (HL7) Implementation Guides** published by the CDC.

# What is the difference between legacy GRITS and GRITS 2.0?

GRITS 2.0 is built on an entirely new platform. The look at feel will be completely different. The platform that GRITS 2.0 uses is extremely user friendly and contains numerous features and resources to ensure users are supported as needed. If you are currently accessing GRITS through your EMR/HER, there will be a seamless transition with no impact to the provider.

# When is GRITS 2.0 expected to go live?
