MPH Rules Update

Adapted from the NAACCR Narrative, Winter 2007 Edition

The new multiple primary and histology coding rules are effective for malignant tumors diagnosed on and after January 1, 2007. One of the main concerns expressed by cancer registrars throughout the US and Canada has been whether they would have access to adequate training prior to the implementation date.

In September 2005 and August 2006, SEER and NPCR conducted Train the Trainers Workshops. Ninety-nine participants from 48 states, the District of Columbia, Canada, Palau, and Puerto Rico completed the training. To date, these trainers have reported 59 trainings that have taken place in the US and Canada during the fall months of 2006. More than 3100 registrars from 47 states and 10 Canadian provinces have participated in these workshops.

A list of trainers has been posted on the SEER website at <u>http://seer.cancer.gov</u> to assist cancer registrar association meeting planners.

There is also a calendar of trainings posted on the SEER website. The trainers will be entering the date and location of each of the workshops they will be conducting. Registrars are urged to use this calendar to find training events located in their region. Each event listed on the calendar will include an e-mail address to obtain further information about the training.

In addition to the local and regional workshops, central and hospitalbased cancer registrars have participated in a series of live web-based trainings conducted by SEER (starting October 25, 2006 concluding April 6, 2007). The series includes an introduction to the Rules; sitespecific training with a practicum for each of the rule sets, malignant brain, breast, colon, head and neck, kidney, lung, melanoma, other sites, and the urinary system; and the new data items. The live sessions are being recorded and posted on the SEER website.

There is no charge for viewing these sessions; no password or username is needed to open the presentation. A total of <u>22 CEUs</u> have been awarded by NCRA and a certificate will be available online upon completion of the practicum. <u>We</u> <u>encourage registrars to use these recorded</u> <u>sessions</u>, especially when they are not able to attend in-person training or when they feel the need to review information from an in-person training or when they feel the need to review information from an inperson training.

<u>The recorded sessions will remain</u> on the website throughout 2007 to support registrars. After they have started using the rules, registrars will be able to access these training modules and practicums as a review or refresher course.

As you know, Sumter Regional Hospital was heavily damaged by a tornado on March 1st. Several of you have e-mailed and called asking if we had any information on the status of Cecilia Fountain, the registrar at Sumter Regional and a fellow GATRA member.

Cecilia lives in Cordele, GA and her home was not damaged during the storm. However, the hospital suffered extreme damage. The estimated time to rebuild the facility is currently six months to one year. We don't know at this time what effect that will have on Cecilia's position in the registry, i.e. whether they will be relocating to a temporary location or completely shut down during the duration of the rebuilding process.

Sumter Regional Hospital By Joy Thompson, GATRA

The hospital did have insurance against disruption of services and are receiving federal aid, but it is unknown at this time how long either of these will last or to what level they are covering employee salaries and such.

Currently, Cecelia is at Phoebe Putney in Albany, helping nurses sort out the oncology charts that were damaged by water in the storm. Carol Crosby will be working with Cecelia in the area of data submission. Betty Gentry will be keeping in contact with Carol on what specific needs the registry might have in terms of help with data submission.

The Executive Board has also discussed other ways in which GATRA might help. Several ideas were considered and the final decision was for GATRA to pay for the cost for Cecelia to attend the GATRA Fall Meeting as well as providing a gift card in the amount of \$500 for the purchase of office or other supplies needed to re-establish the registry office.

I'd like to ask that you all please remember Cecelia, the other hospital employees, and all the residents of this area in your thoughts and prayers. The level of devastation is high and it will take quite a while for this area to recover.

Cancer Stat Bite By Chrissy McNamara, GCCR Epidemiologist

- The overall age-adjusted cancer incidence rate for Metro-Atlanta* (1999-2003) is 466.6 per 100,000 population. This is similar to the overall rate for Georgia (463.3 per 100,000). Between 1980 and 1992, incidence rates increased by about 2.7% per year from 395.6 to 522.0 per 100,000 population. Between 1992 and 2003, the rates decreased by about 1.2% per year to 450.7 per 100,000 population.
- The overall age-adjusted cancer mortality rate for Metro-Atlanta* (1999-2003) is 185.2 per 100,000 population. This is significantly lower than the overall rate for Georgia (201.1 per 100,000 population). Between 1980 and 1989, mortality rates increased by about 0.1% per year from 202.0 to 219.3 per 100,000 population. Since 1989, the rates have been decreasing by about 1.5% per year to 173.3 per 100,000 population.

FAQ's

Q: In the presentation on the 2007 multiple primary and histology coding rules, you stated that the histology should be coded using information from the final pathologic diagnosis, but grade/differentiation can be coded using other information from the pathology report. Please clarify.

A: At the 2007 multiple primary and histology coding train the trainer session, it was emphasized that when coding the histology, only information from the final pathologic diagnosis should be used. It was also stated that those rules do not apply to coding the grade/differentiation.

Q: When using the 2007 multiple primary rules, if the site-specific timing rule states that 'tumors more than 60 days apart are multiple primaries', is 60 days the same as 2 months?

A: No. We can't assume that 60 days and 2 months are the same because not every month has 30 days.

Q: In the presentation on the 2007 multiple primary and histology coding rules, you presented a list of ambiguous terms. You stated that there is no longer a 'no negative' list. Does this just apply to the multiple primary and histology coding rules?

A: Yes. The list of ambiguous terms documented in the 2007 Multiple Primary and Histology Coding Manual is only used for multiple primaries and histology coding. There are different lists of ambiguous terms for casefinding and staging.

Q: In the presentation on the 2007 multiple primary and histology coding rules, you stated that the histology should be coded using information from the final pathologic diagnosis. Can we use information from 'comments' on the path report? **A:** If comments are added to further clarify the final diagnosis, you

may want to use that information when coding the histology. Please remember 'comments' are not the same as 'microscopic description'.
