The **Security Group** field draws its selections from the Permissions Manager. The selections determine which record types the user can access, create, or edit.

The **Department** field determines if the user's name is in the Inspector name selections. To be in the lists, select "Inspectors"

The **District** and **County** fields limit what jurisdictions the user can access.

The first **Title** field determines if and how the user is counted in the staffing reports

If you have access to the **Administrator Tools**, you will find the **Permissions Manager** in the left side menu. Copies of each of the **Security Group** permission sets are at the end of this instruction document.

System Permissions Summary

Common groups:

- **Administrator** – Total complete system access. Not available to select as group except to other Administrators.
- **Content Managers** – intended for maintaining system tables – not to be used outside State office.
- **County Clerks** – General clerical access to end user tools, but not county managed system tables, like the County Update Tool
- **County EH Managers** – Intended for county supervisors. Same access as Environmentalists group, with access to delete assigned tank inspections and items in the To Be Assigned Queue.
- **Data Entry** – General clerical access to end user tools with no access to Report and Analysis Center and no deletion rights at all
- **District EH Managers** – Equal to Administrators, but limited to assigned District and no access to modify system tables for selection lists or to the Issue Tracker.
- **Environmentalists** – Primary user group. Access to all field operational records, restricted to counties assigned. Typically also requires selecting “Inspectors” in the Department field of the Employee Manager record so their name will appear in Inspector fields in permit and inspection records.
- **State EH Program Managers** – Access to view all record types, but only edit or add to the selection list system tables.

Note: All access rights are viewable in the Permission Manager. This is accessible to all District EH Managers. Complete permission sets are at the end of this document.

Title Field Use

The Title field determines the way users are counted in staffing reports The selections fall into five categories; EHS, EH Tech, Interns, Support Staff, and non-counted.
