

Georgia Department of Public Health – COVID-19 Vaccines
Vaccine Ordering Guidance
As of 3 FEB

Current Ordering Phase: 1A Expanded (Phase begins January 11)

Phase includes healthcare workers (paid or unpaid), laboratory, environmental services, LTCF staff and residents, individuals 65 and older, law enforcement officers, firefighters, and first responders.

Ordering Process:

1. Georgia anticipates federal allocations of Pfizer and Moderna amounts at the end of each week.
2. If Georgia receives a federal allocation, these amounts are then allocated to enrolled providers against current orders that have not been completely fulfilled.
3. Allocations are made based on previous shipments, equitable distribution, storage capabilities, current Phase Priority Populations, and vaccine availability.

When to place orders:

1. You have received all the vaccines you have previously requested; **and**
2. You are still vaccinating in the current Phase group; **and**
3. You have the capacity and capability to use the requested vaccine; **then**
4. Place orders for all vaccines through <https://www.surveymonkey.com/r/GA-COVID19-Orders> by **5pm on Tuesdays**. These orders will be placed for shipment the following week, provided enough vaccine allocation is available.

When not to place orders:

1. You still have an outstanding balance from your previous order; **or**
2. You have completed vaccinations for the current Phase group and have not been advised by the Georgia Department of Public Health to move to the next phase; **or**
3. You do not have the capacity or capability to use additional vaccines.

Second Doses:

1. 14 days after your initial shipment you can place an order for the second dose through the same link: <https://www.surveymonkey.com/r/GA-COVID19-Orders>.
2. This order will be compared to your order history and your GRITS doses administered and inventory information for the designated review period (21 days prior for Pfizer and 28 days prior for Moderna).

What to do When you Complete a Phase Priority Group:

1. Continue to store and monitor any remaining vaccine supply: **and**
2. You may vaccinate partners in the current Phase Priority Group; **or**
3. Wait for guidance from DPH to begin vaccinating the next phase.
