How To Issue Continuing Education Credits (Contact Hours—CH) for Nurses

A master copy of the GNA roster is included in each presentation folder on the presentation CD. Complete all the information in the top section of the GNA roster sheet. (Course identification number is written on certificate and in the presentation chart in this document.)

Have nurses (RN's only) sign in and complete all the information indicated on the GNA roster. (LPN's may receive a certificate of attendance, but not contact hours.)

A master award certificate for each presentation is included in each presentation folder on the presentation CD. Fill in participant's name and the date of the course on the certificate.

Do not issue certificates for participants unless they complete and turn in an evaluation form.

Documenting Evaluations

A master evaluation form is also included in each presentation folder on the presentation CD. Give an evaluation form to every participant. *Using the following formula, tally all the evaluations and enter in total scores for each question on the summary evaluation form:

Tabulate the responses on each item on your evaluation as follows:

Content: The content was interesting to me.....1 2 3--#1 (1 respondent for 3) 4 5--#14 (14 respondents for 5)

Multiply:	03	X	01	=	03

Reporting

Nurse Consultant will be responsible for submitting the roster sheet and the summary evaluation form to the Assistant Chief of Nursing.

How to Issue Certificates for Day Care Providers

Day Care Licensure has granted us permission to award certificates of attendance to participants for the three presentations noted on the chart. Participants may use these certificates to fulfill day care licensure's requirements for in service training. All presentation guidelines, time frames, and AV materials should be utilized as written in the presentation CDs.

Have participants sign in on a master generic roster. A master copy of a generic roster is included in each presentation folder on the presentation CD.

How to Issue Attendance Certificates for Other Attendees

Please use the following guidelines for issuing certificates of attendance for all other persons who attend training sessions. This would apply to any persons who are not listed on the indicated attendance rosters for RNs.

Have participants sign in on a master generic roster. A master copy of a generic roster is included in each presentation folder on the presentation CD.

Documenting Evaluations
