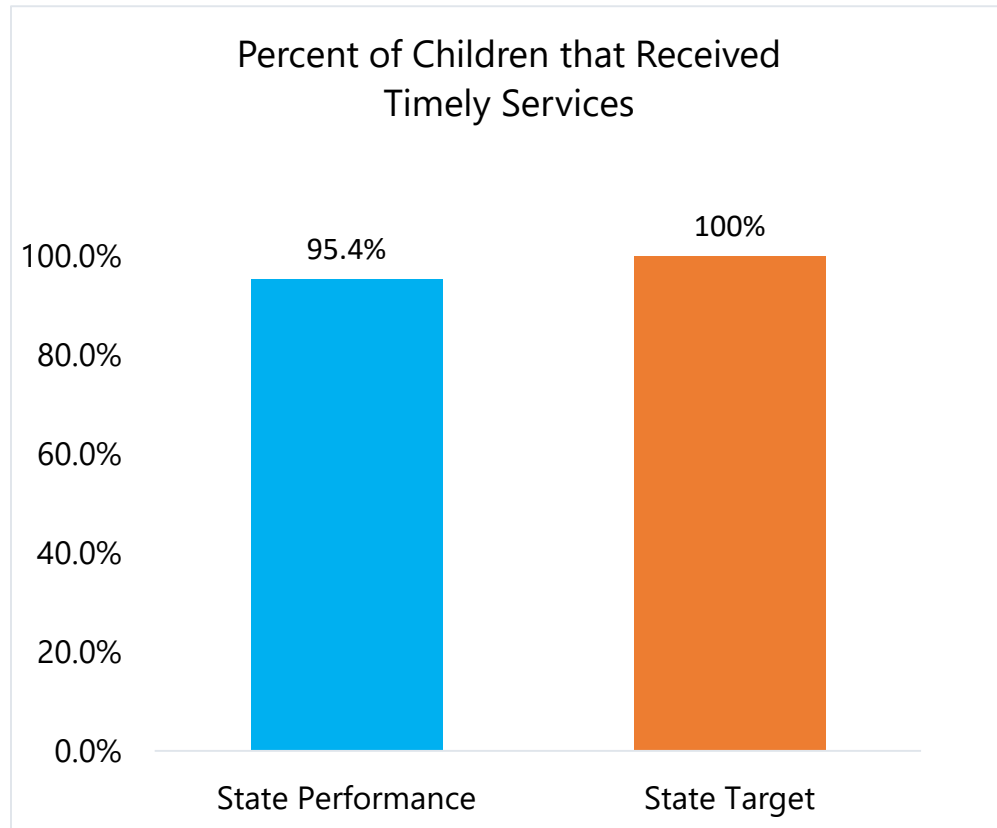

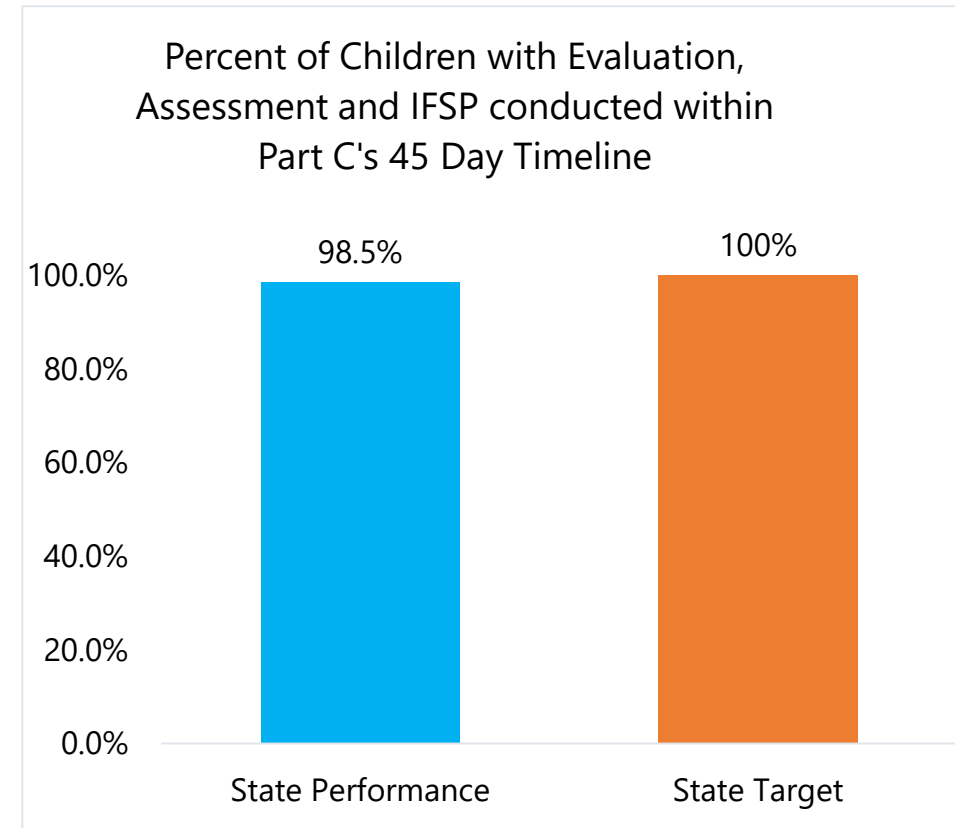

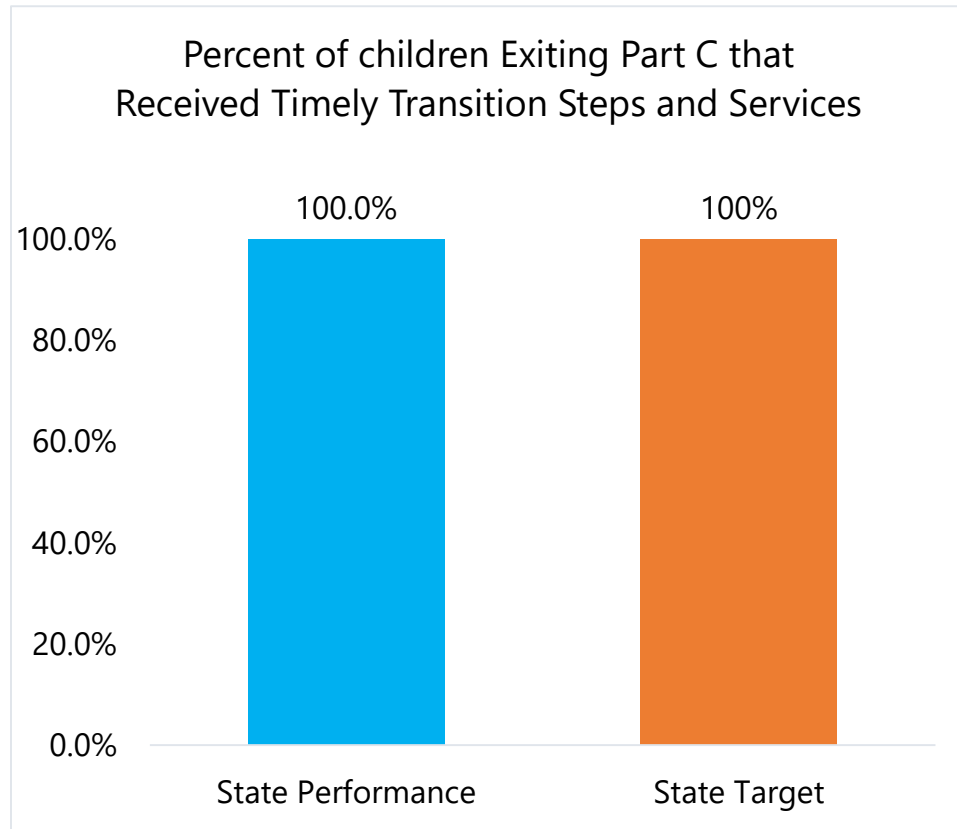


Indicator 1: Timely Service Delivery

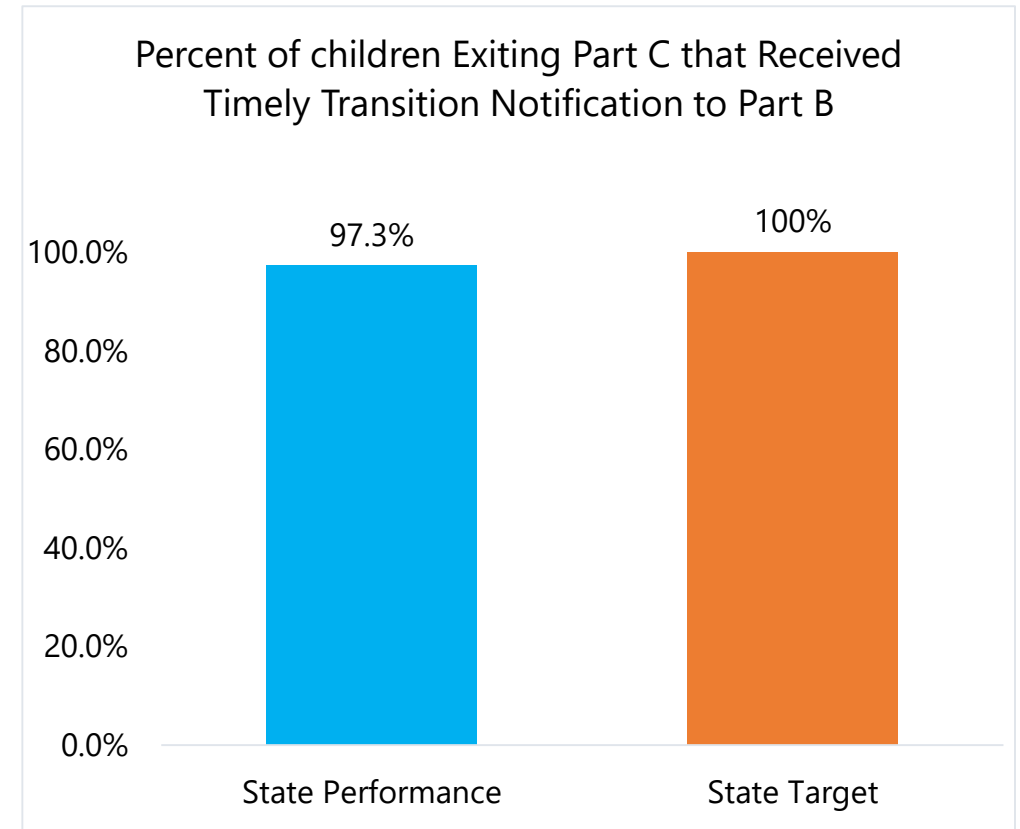


Indicator 7: 45-Day Timeline

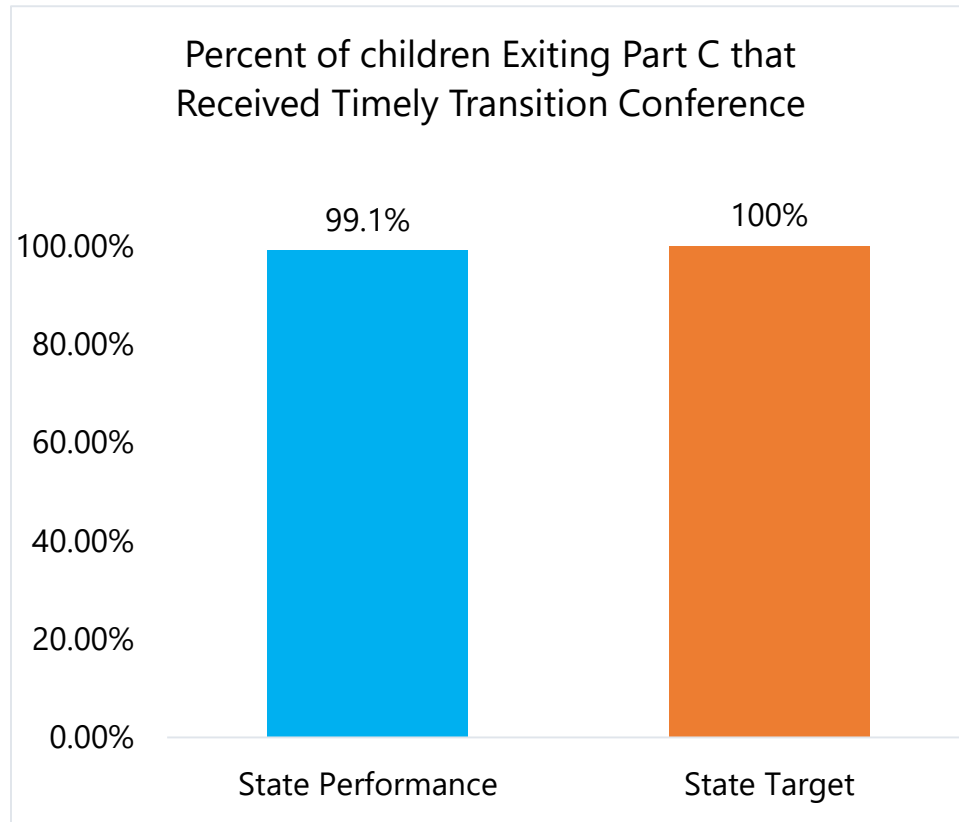


Indicator 8A: Early Childhood Transition

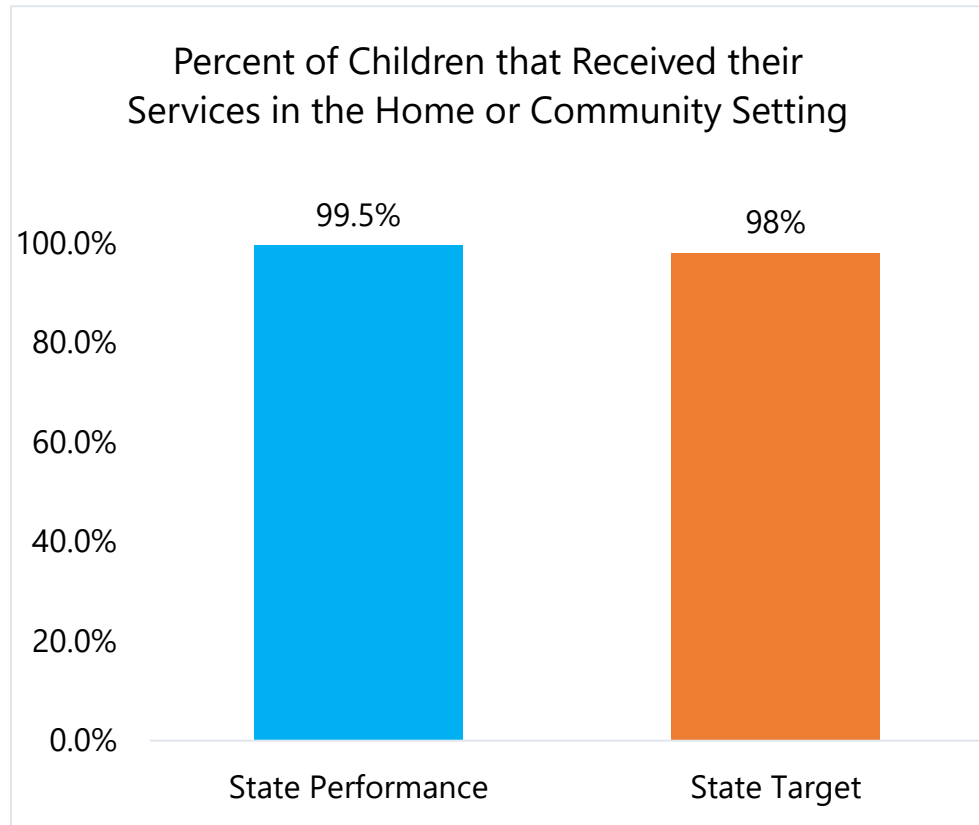

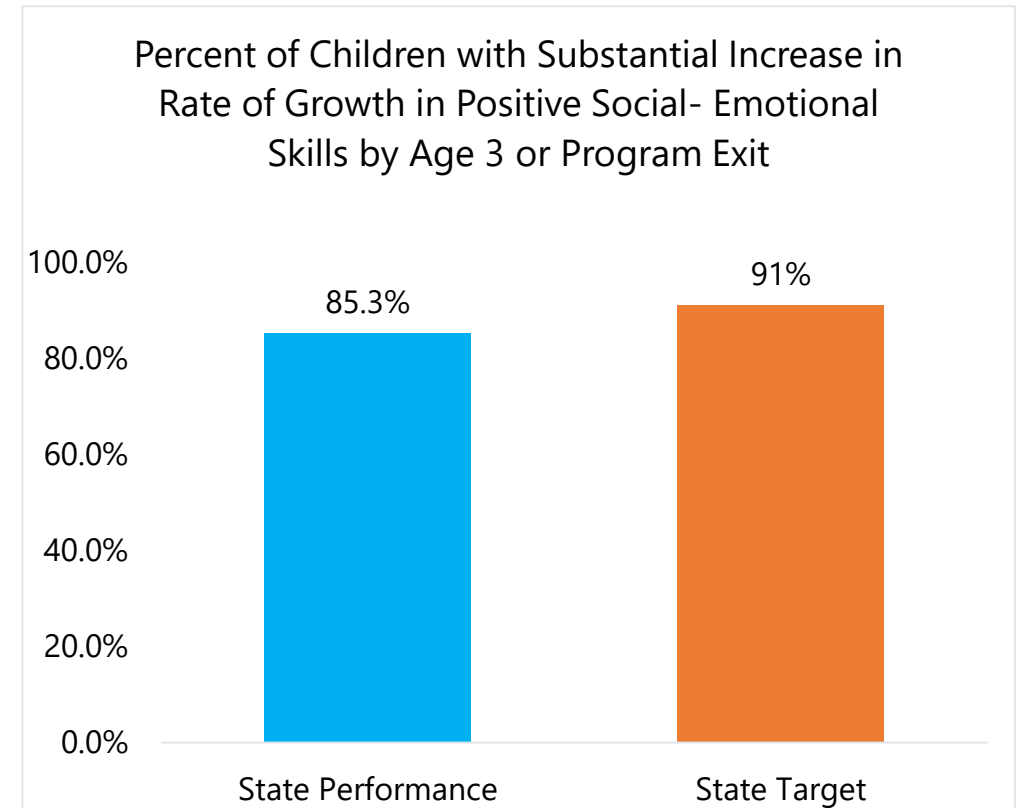

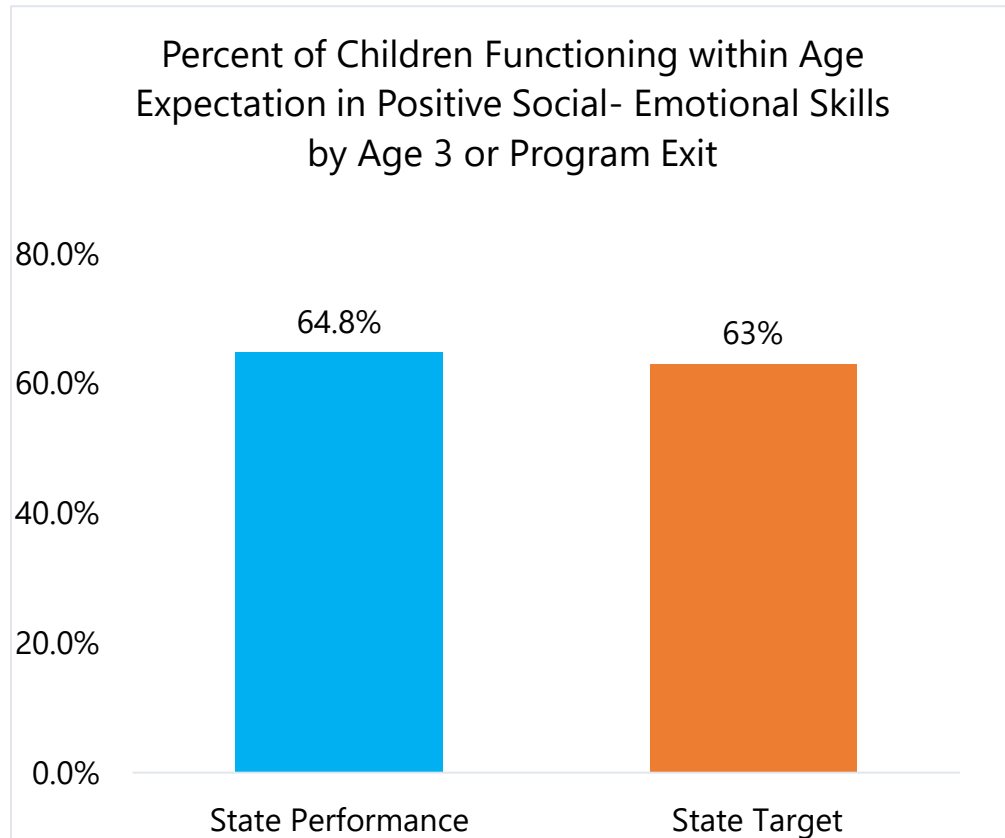


Indicator 2: Settings

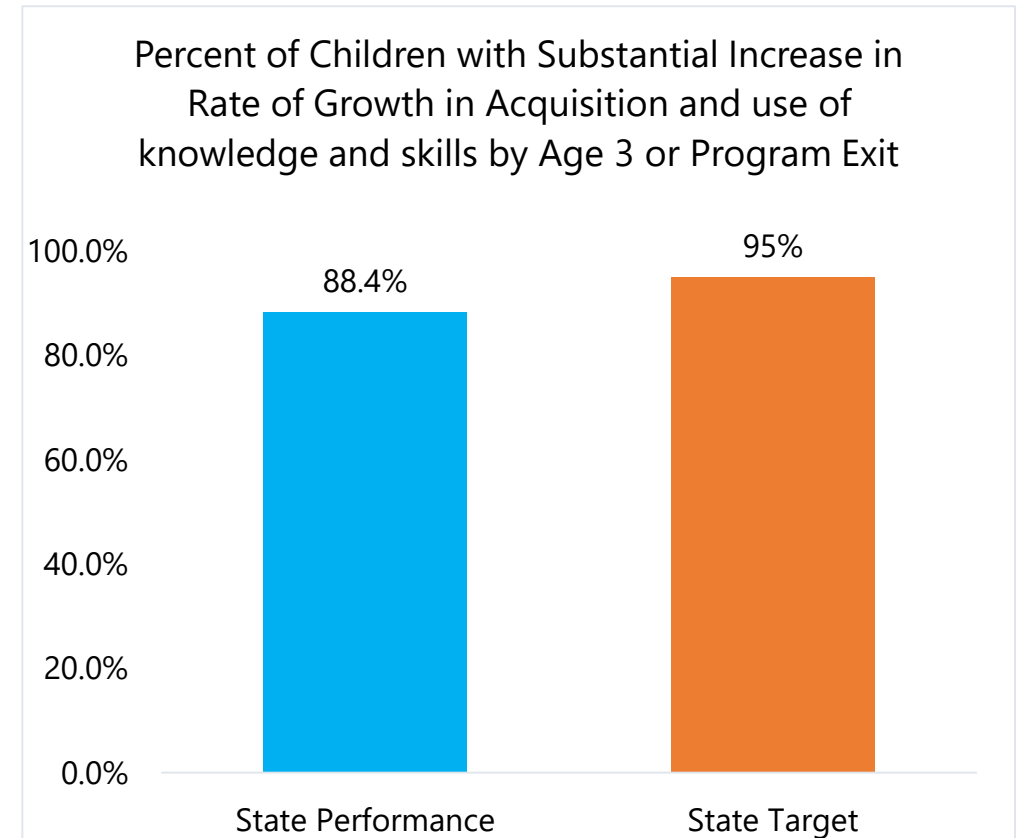


Indicator 3A: Child Outcomes

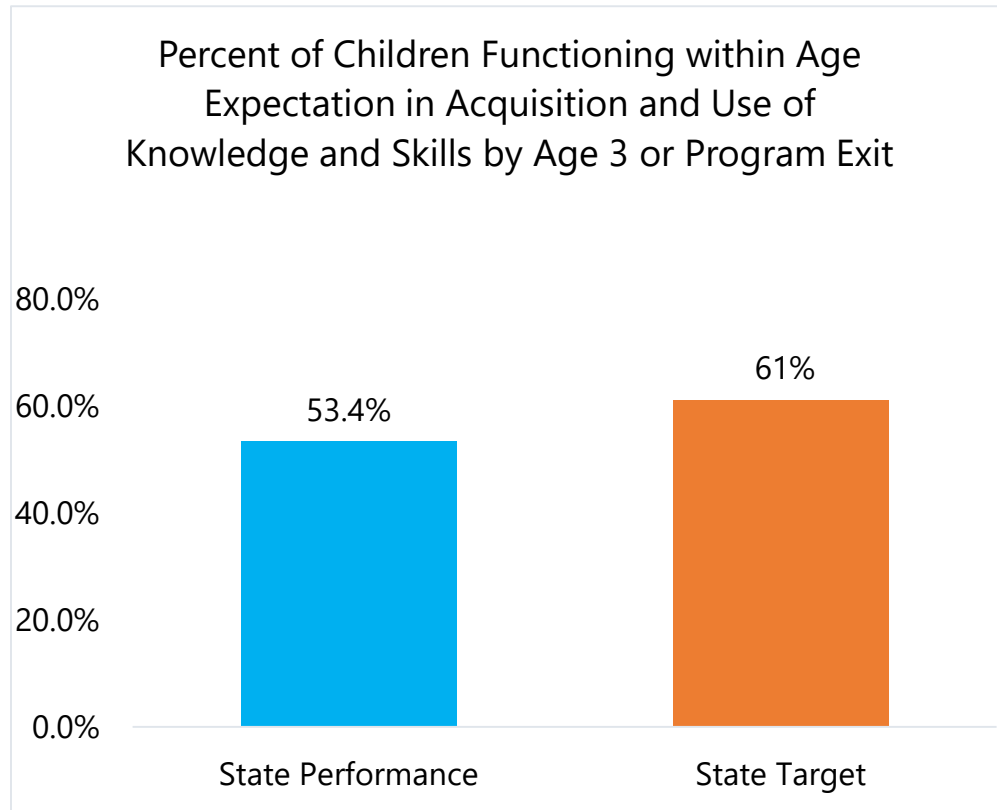


Indicator 3A: Child Outcomes

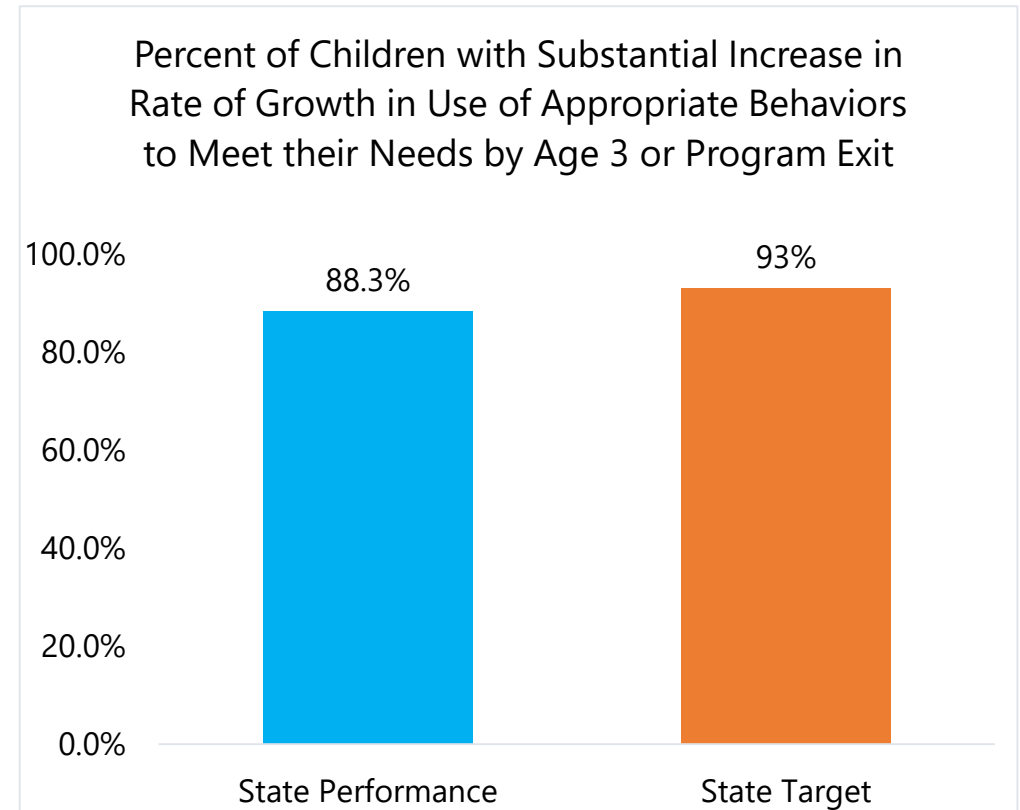


Indicator 3B: Child Outcomes

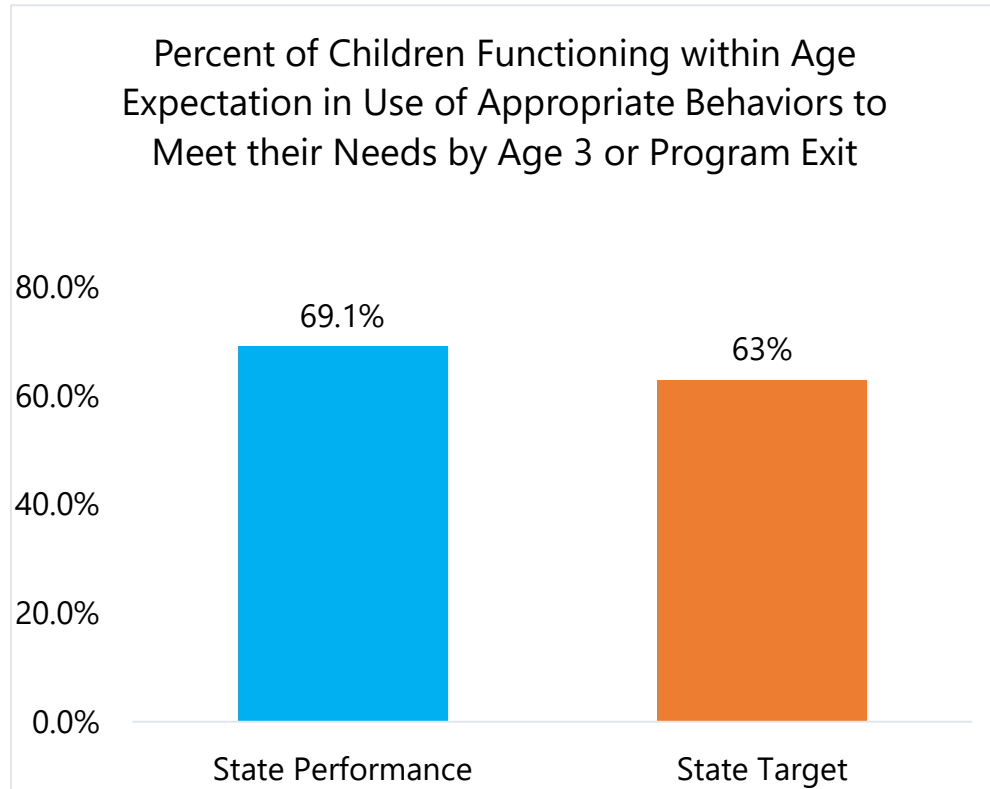


Indicator 3B: Child Outcomes

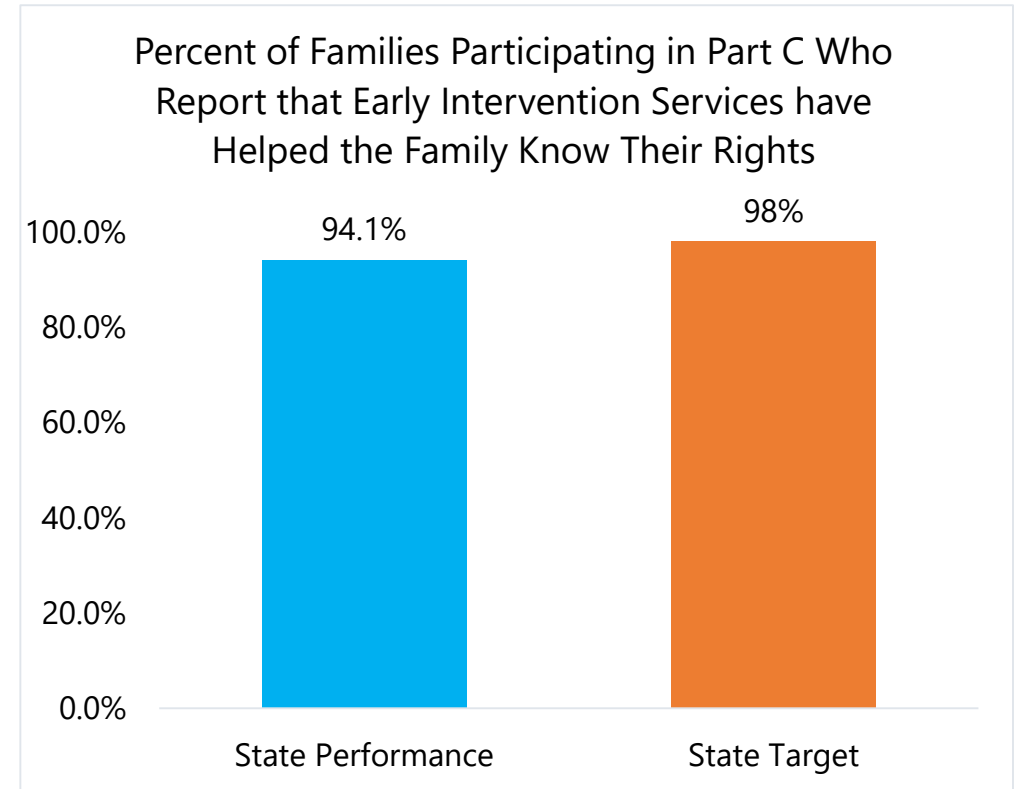

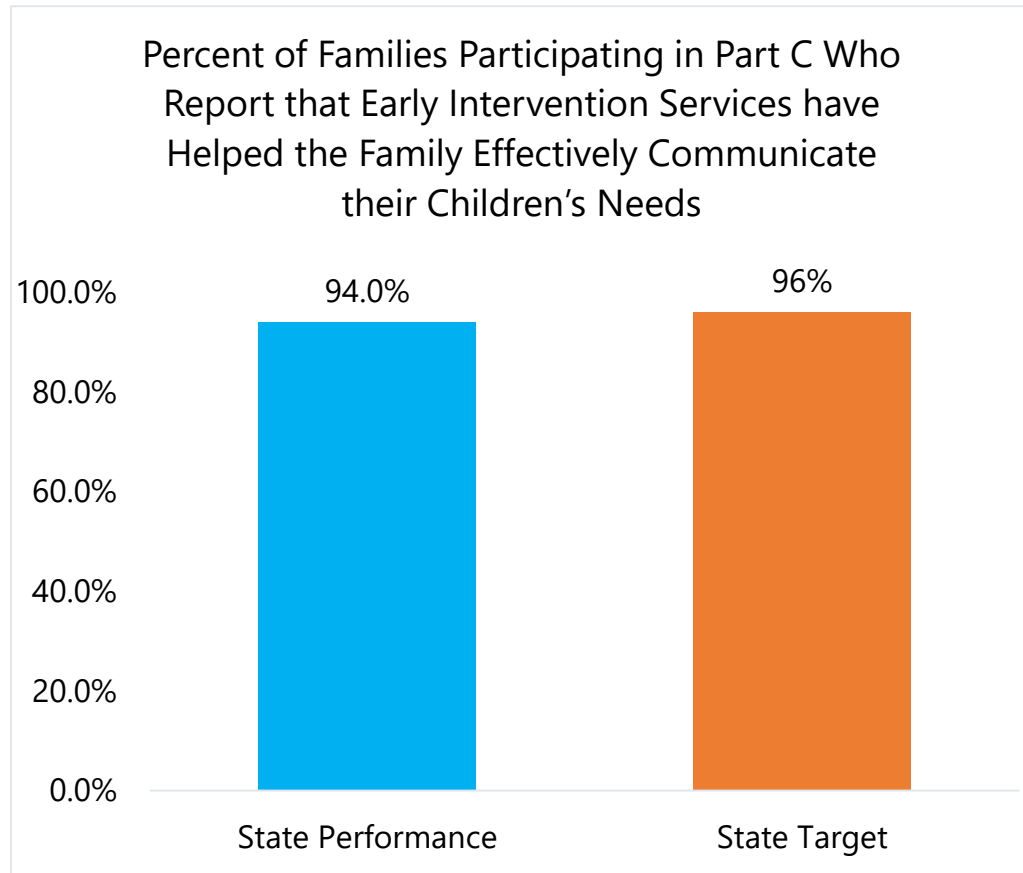

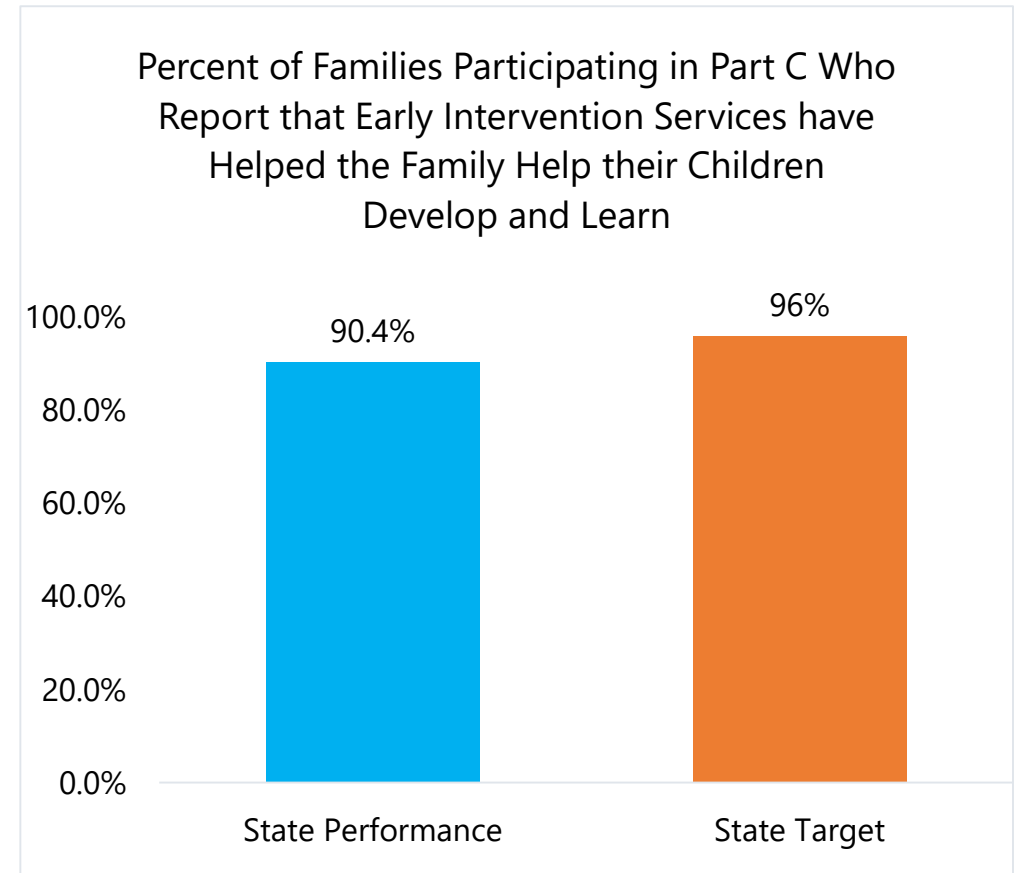

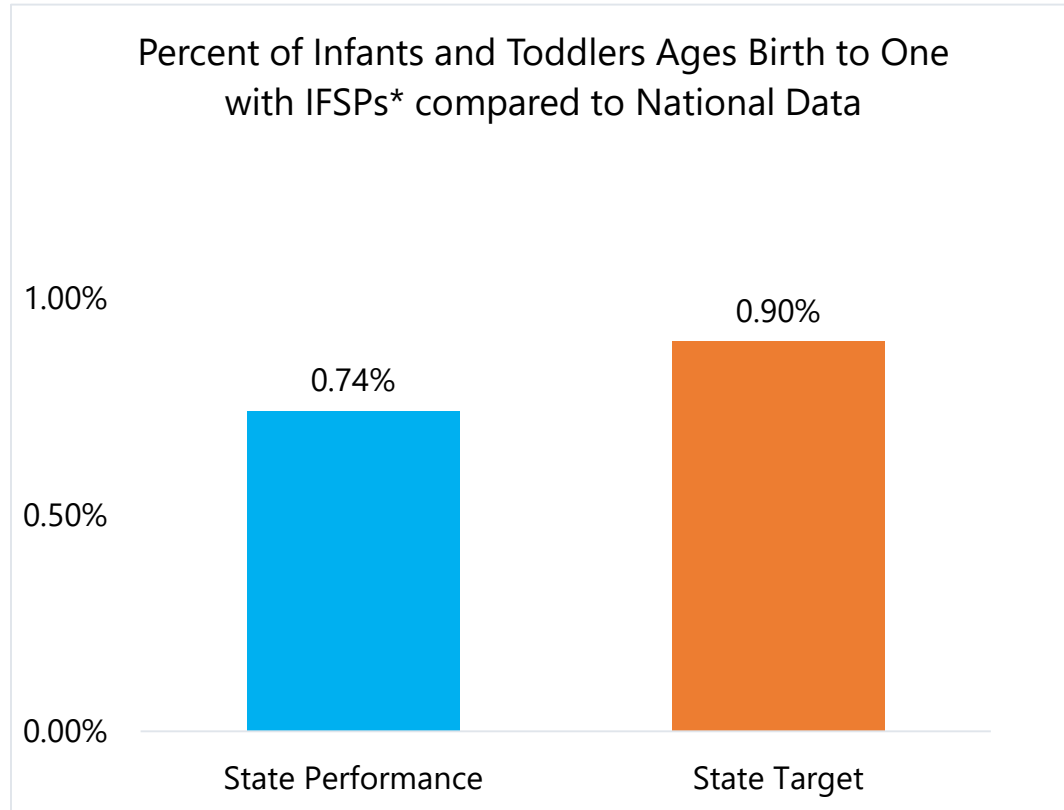


Indicator 4B: Family Outcomes



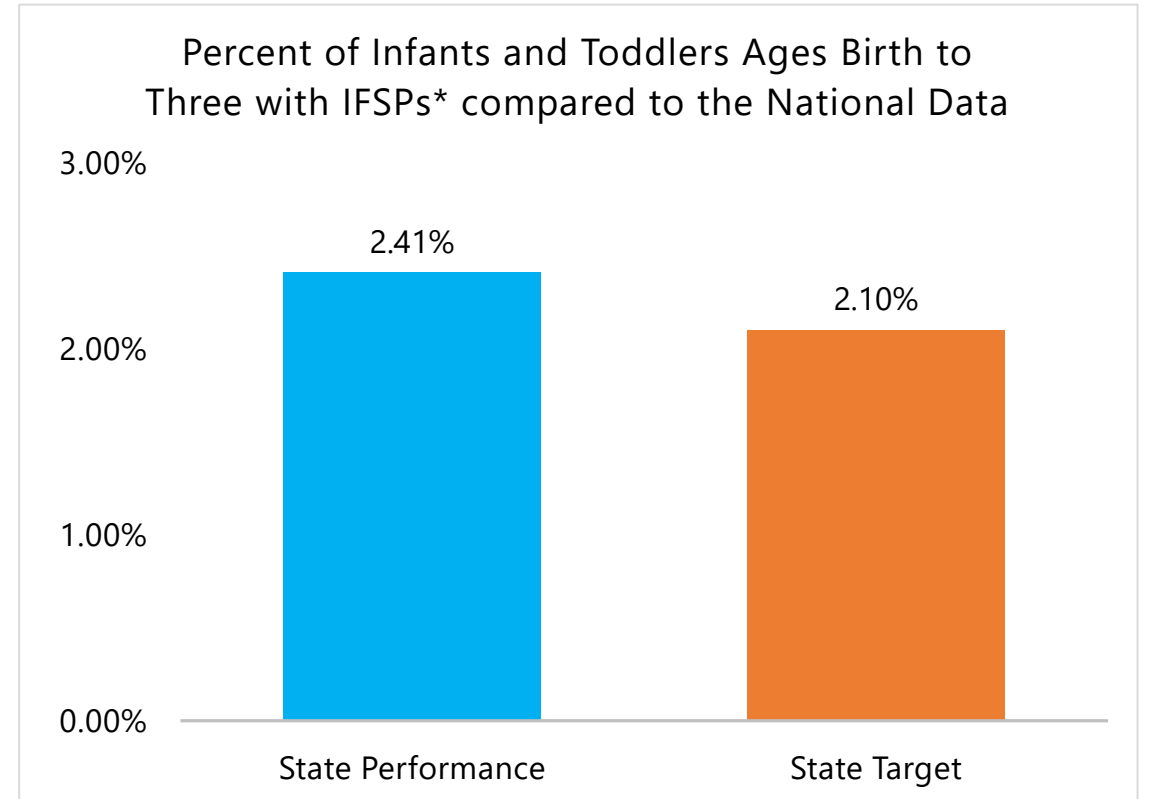

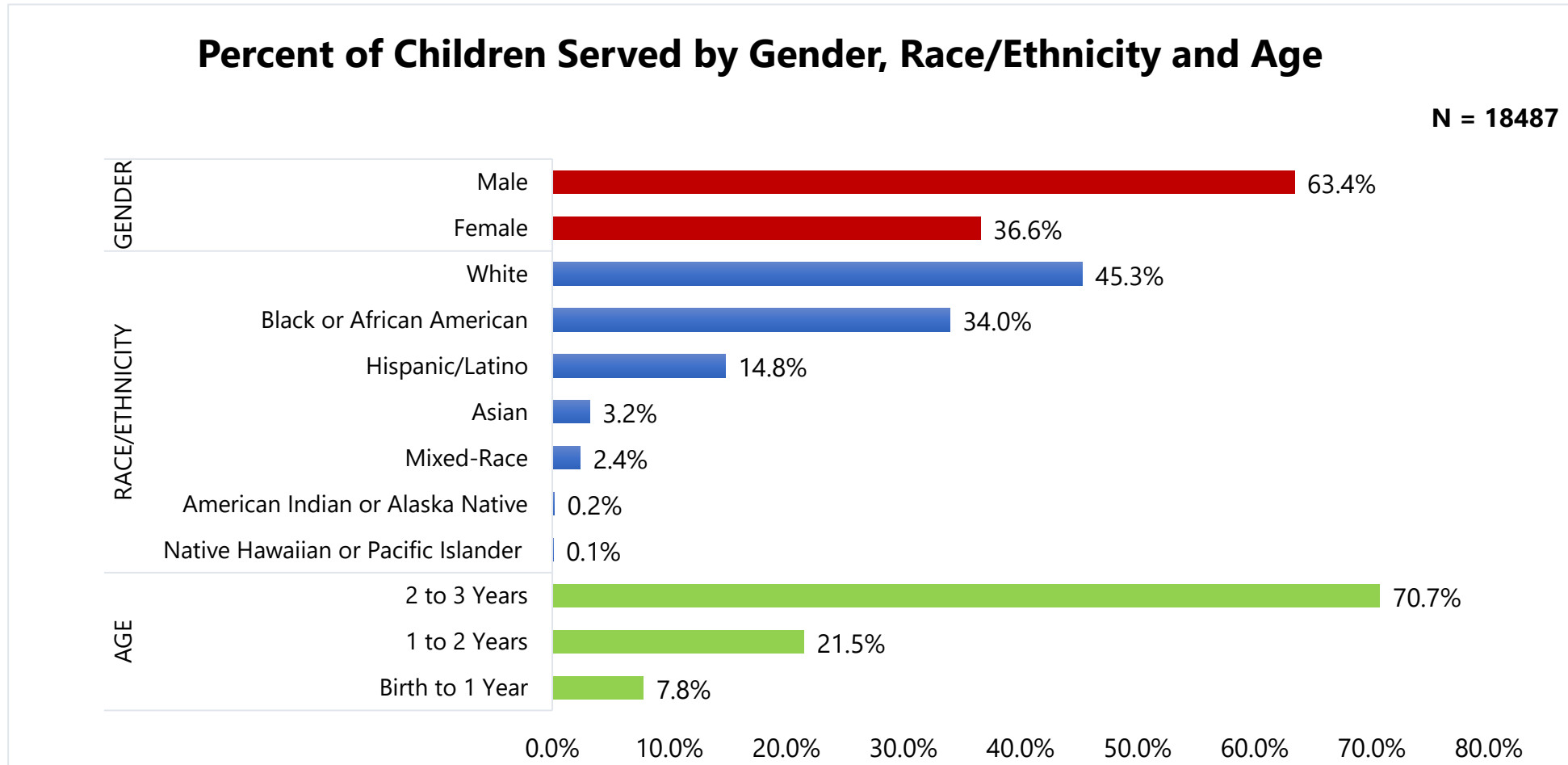
Indicator 5: Child Find, Ages Birth to 1
