Leveraging the EHR to Digitize the GTQL Referral Form

Mr. Bussey is the Tobacco Cessation Coordinator with Georgia Department of Public Health's Georgia Tobacco Use Prevention Program (GTUPP). Mr. Bussey manages the overall operations of the Georgia Tobacco Quit Line (877.270.STOP) and works very closely with the Georgia's Diabetes Program to provide training and technical assistance for the full implementation of Georgia cAARds Program, a multi-component strategy centered on reducing modifiable risk factors such as smoking, which is associated with chronic disease onset and tobacco-related chronic disease complications among Georgians.
